### ORDINANCE NO. 5078

THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS: RELATED TO REZONING IN THE EL DORADO/ DIAMOND SPRINGS AREA, (DANNY OLIVER/ VERITAS CAPITAL, LLC):

**Section 1.** The Official Zoning Map for the El Dorado/Diamond Springs area is hereby amended to rezone the following described lands:

From: Commercial Limited (CL)

To: Single-Unit Residential (R1)

**El Dorado/Diamond Springs Area:**

Assessor's Parcel No. 329-162-59, being described as a portion of Section 26, T10N, R10E, M.D.M, consisting of 0.25 acre.

**Section 2.** This ordinance shall take effect and shall become effective thirty (30) days following the adoption hereof.
