#### AGREEMENT FOR SERVICES #022-S1711

#### AMENDMENT II

This Amendment II to that Agreement for Services #022-S1711, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Sonitrol of Sacramento LLC, duly qualified to conduct business in the State of California, whose principal place of business is 1334 Blue Oaks Boulevard, Roseville, California 95678 (hereinafter referred to as "Contractor").

#### RECITALS

**WHEREAS**, Contractor has been engaged by County to provide routine monitoring, maintenance and repair services and on-call maintenance and emergency repair services for the access control systems at various County-operated facilities in accordance with Agreement for Services #022-S1711 dated June 22, 2016, and Amendment I dated September 23, 2016, both incorporated herein, including all attachments and exhibits thereto, and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to increase the total amount of said Agreement by \$50,000.00 for a new not-to-exceed amount of \$350,000.00, hereby amending **ARTICLE III – Compensation for Services**.

**NOW, THEREFORE**, the parties do hereby agree that Agreement for Services #022-S1711 shall be amended a second time as follows:

**ARTICLE III – Compensation for Services paragraph three (3) is amended and replaced in its entirety as follows:**

The total amount of this Agreement shall not exceed \$350,000.00, inclusive of all Work Orders, costs, and expenses.


