If you actually drove by and looked at the lot you would see that this effort is futile. Anyone trying to sell it would be filling around six dumpsters with junk that's everywhere. C.E. seems to only care about the house, I care about the safety and environmental hazards throughout the lot. The fire seemed to originate on the back of the house. That is where they had built a plywood room for growing their marijuana plants. No cleanup of the fire debris has occurred (eight months and counting). All of this potentially hazardous material needs to be cleaned up before it rains. I realize that you are the one that makes his office operate smoothly everyday but I think it is time that you pass all of this onto him so he can get this taken care of.

Good morning,

John and I did a site visit to this property on Wednesday.

The property owner was not there; two friends who were helping the owner were there.

There was no sign of any new construction, or any new lumber or building materials; one of the people there said that there was a recent Home Depot lumber drop just up the street, but not at this site.

There was no furniture in the house; it was being cleaned out of any/all damaged belongings and materials (walls, etc).

A portion of the wire fence in front has been removed; a short board fence has been placed in it's stead.

There was evidence of much clean up done recently; the friends confirmed that the owner is trying to make the property more presentable, to get a better offer for purchase of the property.

The real estate sign is still posted at the corner of the property; a call to the realtor confirmed that the property is still for sale.

I placed a call to one of the resident deputies to inform him of the recent concerns from several citizens; he said he received at least one call himself, would keep an eye on the property, and speak to the other resident deputies to let them know of the properties status.

They are in the process of combining several households items into one location, the property at 3998 Harris Rd.

Environmental Health/Solid Waste division is also aware of the property, and along with our Code Enforcement Unit, have been working with the owners to get things cleared &/or cleaned up there.

When I was at the site last week, there was power; there was no one occupying either of the two trailers on the property, both were clearly being used for storage, which is allowed as far as the requirements that we enforce.

As for the loud music, the Sheriff's Dept would handle that.

The Benefits of Humor and Quiet in Our Age of Ranting Politics

The last time I spoke from this podium was on September 25th. I began by providing you with a full-page blowup of a Gary Larson single-panel *Far Side* cartoon, which I suggested that you keep to refer to when confronted by punishing situations and people. I did what I did in the firm belief that humor in the face of unrelenting stress is the best prescription for taking oneself too seriously and losing faith in what I call the "Art of the Possible."

Please know that my providing that cartoon was not intended to be a comment on anyone who spoke before me or later, nor was my doing so intended to suggest that I do not take the deliberations of the Board seriously, or that in the future I do not intend to join in them to the extent I am able. I hold to the belief that contributing one's opinions is what a responsible citizen ought to do, insofar as those opinions are aimed at trying to help address problems and not just serve to rant or complain about them.

After distributing that cartoon, I announced that I would soon be departing El Dorado County for a while, to go on a much-needed retreat at a monastery. To clarify a point, I did not go to a Hindu ashram or Buddhist place of meditation, though at some time in the future I may go to either. No, the place I retreated to was at the Abbey of New Clairvaux, founded in my living memory in the year 1955, near the small community of Vina, near where Deer Creek joins the Sacramento River, roughly 20 miles north of my hometown of Chico, California.

As the website (at https://www.newclairvaux.org/) of the Abbey explains to those who may be interested:

We are Cistercians of the Strict Observance, a Roman Catholic order of monks founded by Saints Robert Alberic and Stephen Harding in the year AD 1098. Today, we are commonly known as "Trappists." With the ancient Rule of Saint Benedict as our guide, we offer hospitality to guests, serve in mutual charity, and live out our contemplative witness of silence, stillness and solitude in our often frenetic and busy world today.

Simple, Spartan, a single bedroom with a small bathroom, three vegetarian meals a day provided, few other guests, no television or radios or computers, no scheduled events, no agenda, walks to wander and think, vineyards, walnut and prune orchards, the land long ago settled and farmed by the remarkable California pioneer Peter Lassen — later owned by Leland Stanford who on that site built what he claimed was the world's largest vineyard — now with an especially lovely mature walnut orchard, all as I remember it in the 1950s when I visited there as a youngster.

Except for the distant passing of a few freight trains a day, the quiet there I found surprisingly disorienting the first day or so I was there, which in retrospect should have been no surprise, given the almost-constant din of living near Highway 50 in the vicinity of Placerville and Camino, the road-noise capitol of the northern Sierra foothills — a difficulty that could be dealt with, if those who could would decide to do so.

Cost per night at New Clairvaux: \$80.00, simple and no frills. Less for those who cannot afford \$80.00.

I recommend it for those seeking peace and restful solitude.
