3. El Dorado Water Reliability Project: Presentation and Discussion Regarding Options for the Organizational Structure

This item continued from the July 11, 2018 Board of Directors meeting.

The El Dorado Water & Power Authority (EDWPA) continues to pursue a long-term water supply for El Dorado County as established in the County's General Plan and provided in the 2005 agreement between El Dorado County (EDC), El Dorado County Water Agency (EDCWA), El Dorado Irrigation District (EID) and the Sacramento Municipal Utility District (SMUD). This Agreement is commonly referred to as the "SMUD Agreement." At the June 13, 2018 Board meeting, the EDWPA Board received an update to the El Dorado Water Reliability Project (EDWRP). Because of the expiration of one of the guiding agreements between EDC, EDCWA and EID, known as the "Inter-County Coordination Agreement" (ICCA), the EDWPA Board requested the Executive Director develop options for the Board to consider and to allow

the EDWRP to move forward in an efficient and uninterrupted process as provided in the 2005 SMUD Agreement. The purpose of this agenda item is to provide the Board with options to continue the EDWRP as provided in the SMUD Agreement, and to provide direction to the Executive Director for actions necessary to move forward in an efficient and uninterrupted process.

BOARD ACTION: Motion by Director Veerkamp, seconded by Director Hidahl, the Board approved staff put together a timeline and draft itinerary to be presented at the November 13, 2018 El Dorado County Board of Supervisors meeting and the November 14, 2018 El Dorado Water & Power Authority Board of Directors meeting, approved.

A written copy of the Executive Director's Power Point Presentation to the Board this date is attached and made a part of this Conformed Agenda.





EDWRP - PROJECT OVERVIEW

1927 PRIORITY WATER RIGHT

- Extension of the Upper American River Project (SMUD)
- Consistent with provisions in the Cooperative Agreement Collaboration with the City of Sacramento
 - SacCity also uses SMUD facilities in diverting, rediverting, and storing their appropriated water rights.
- STATE BOARD APPLICATION 40,000 AFY American River
 - Partial Assignment of existing water right (SMUD)
- USE WATER AS A REGIONAL ASSET FOR MULTIPLE BENEFITS:
 - El Dorado County future M&I + Ag demands
 - Interim Benefits:
 - LAR environmental water
 - LAR basin groundwater banking / conjunctive use
 - Water Transfers (Interim or regional)







 - · Clarifies conditions for withdrawal from JPA and winding up of of JPA
 - Requirement for affirmative votes of 6 necessary for budget adoption
- 2008 Second Amendment
 - Designated Executive Director of EDWPA as Treasurer and Auditor for JPA
 - Deletes requirement for a affirmative votes of 8 necessary for budget adoption

2009 (March) Transition Agreement

- GDPUD, EDC, EID & EDCWA
- GDPUD withdraws and is released from rights and obligations of the Coordination & Costs Share Agreements
- GDPUD remains a party to the Cooperation Agreement



	El Dorado Designated Representative: Responsibilities
19.1	El Dorado Designated Representative. The El Dorado Parties agreed that the El Dorado Designated Representative will be the "sole and exclusive Party" for the following purposes:
19.1.1.	Water Supply Acquisition. Process of acquiring the water rights and water supplies to be stored, and diverted through and from the UARP
19.1.2	Notices. Representative to provide and receive all notices.
19.1.3	Scheduling of Deliveries . Comply with all forecasting, scheduling and notice requirements for each El Dorado Party the quantity of water delivery being forecasted.
19.1.4	Notification of Interconnection Construction Agreement. Negotiations of the Interconnection Construction Agreement.
19.1.5	Construction, Maintenance and Operation of Interconnection Facilities. All matters related to the construction, maintenance and operations of the interconnection facilities.
19.1.6	Negotiation of and Communications under the Data Interchange Agreement . Negotiation of and communications under the DI Agreement.
19.1.7	Installation, Maintenance and Calibration of White Rock Meter. Installation, maintenance and calibration of the White Rock Meter.
19.1.8	Reporting of Deliveries - Reporting requirements.
19.1.9	Re-opening of this Agreement. Negotiations pursuant to a re-opener.

Projections of supply and demand:

- Water Demands based on net-developable areas within the "Capacity of General Plan"
 - · Agency-specific Urban Water Management Plans will be referenced for projected build-out demands
- Consider the State's conservation goals and best management practices.
- Establish the initial comparison between supply and demand and define the Study baseline.

Impact analysis:

- Leverage recent investments
 - · Analytical tools for local project operations in the upper American River Basin,
 - · American River Basin Study (ARBS)
- Information on regional infrastructure capacity.
- Refined hydrology to be developed through the ARBS
 - · Used to assess regional and agency-specific vulnerability to climate change
 - · Used to assess the effectiveness of identified mitigation and adaptation strategies.


Trade-off analysis:

- Range of strategies will be identified, including structural improvements, operational improvements, and institutional / administrative improvements.
- Strategies
 - Formulated to address projected climate change impacts,
 - Improve regional self-reliance in water supply,
 - · Align regional and federal water management strategies, and
 - Enhance the operational flexibility at for Folsom Dam.
- Evaluation criteria with stakeholder input and consistent with Federal planning guidance (effectiveness, efficiency, acceptability, and completeness).






CalSim 3, developed by Reclamation and DWR, provides a state-of-the-art integrated platform for simulating regional and statewide water systems. It includes:


- A detailed representation of the water supply portfolio of individual water purveyors in the region.




Moving Forward with EDWPA


