AGREEMENT FOR SERVICES #847 (449-S1311) AMENDMENT I

This Amendment I to that Agreement for Services #847 (449-S1311), is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and BHC Sierra Vista Hospital, Inc., a Tennessee Corporation doing business as Sierra Vista Hospital, Inc., duly qualified to conduct business in the State of California, whose principal place of business is 8001 Bruceville Road, Sacramento, CA 95823 (hereinafter referred to as "Contractor") and whose Agent for Service of Process is Corporation Service Company doing business as CSC-Lawyers Incorporating Service, 2710 Gateway Oaks Drive, Suite 150N, Sacramento, CA 95833;

RECITALS

WHEREAS, Contractor has been engaged by County to provide eligible County residents (adults and children) with access to designated mental health services, including acute psychiatric care, in accordance with Agreement for Services #847, dated June 10, 2014, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to amend **Article IV, "Compensation for Services, Sections E and F," and Article XVIII, "Notice to Parties"** of said Agreement.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #847 shall be amended a first time as follows:

1) Article IV "Compensation for Services, Sections E and F." is amended in its entirety to read as follows:

Article IV

Compensation for Services:

E. Invoices/Remittances: Invoices / Remittance shall be addressed as indicated in the table below or to such other location as County or Contractor may direct per Article XVIII, "Notice to Parties."

For services provided herein, County agrees to pay Contractor monthly in arrears and within forty-five (45) days following the County's receipt and approval of itemized invoice(s) identifying services rendered, except as set forth in paragraph C "Other Fiscal Provisions" and paragraph D "Client Billing" herein.

F. Not to Exceed: the maximum compensation payable under this Agreement shall not exceed \$300,000 during any fiscal year, which shall be defined as the period commencing July 1st and ending June 30th of the following calendar year.

2) Article XVIII "Notice to Parties" is amended in its entirety to read as follows:


