I forward to both your office and the District III office the following information submitted by the American River Conservancy to request \$5,000 in funding for the WakamatsuFest150. WakamatsuFest 150 is scheduled for June 6 - 9, 2019.

Per the County's guidelines regarding Community Funding Requests, Melissa Lobach of the American River Conservancy has included a completed funding request form as part of the submitted request for funding packet.

I have also attached a letter from Alan Ehrgott, Executive Director of the American River Conservancy, for additional reference. You will note that in his letter, Mr. Ehrgott requests \$10,000 in funding/sponsorship support from the County. Event/Project Description

1. Describe the purpose of the event/project/organization for which funds are being requested.

In 2010, ARC purchased the 272-acre historic location of the Wakamatsu Tea and Silk Farm Colony. Located a few miles from California gold discovery in Coloma, the first Japanese settlers in North America arrived at Wakamatsu Farm on June 8, 1869. Considered the "Plymouth Rock" of the Japanese-American immigration story, Wakamatsu Farm is a place of several first honors, including 1) Site of the first Japanese colony in America; 2) Birthplace of the first Japanese American; 3) Resting place of the first Japanese immigrant woman. At the age of 19, young Okei-san died in 1871, and her grave remains on the Farm. Wakamatsu Farm is California Registered State Historic Landmark #815 and listed on the National Register of Historic Places at a level of National Significance.

To honor the first Japanese colonists' arrival at Wakamatsu Farm 150 years ago, the Conservancy will host a sesquicentennial 4-day festival on June 6 through 9, 2019. Called **WakamatsuFest150**, the festival is a one-time-only celebration of 150 years of Japanese-American heritage, arts, and cuisine. Exactly 150 years after the first Japanese colonists' arrival, the 4-day event will honor Japanese American people and their extraordinary role in American history.

WakamatsuFest150 will feature food, art, music, performances, demonstrations, discussions, lectures, competitions, and merchandise unique to the Japanese-American culture. Tour guides will tell stories about the first Japanese colonists who established their tea and silk farm on the Placerville property. Each day of the festival, visitors will be treated to a live action play of the historic colony story. Locals, farmers, historians, and naturalist will share knowledge and experience honoring the past, present, and future of Wakamatsu Farm and surrounding El Dorado County.

WakamatsuFest150 is an historically significant event that will never be repeated anywhere, anytime, ever again in world history. ARC ask the El Dorado County Board of Supervisors to support the momentous occasion at the \$5,000 "Samurai Honor" sponsorship level. Please see the attachment for the description of gifts offered at this sponsorship level.

2. How will the event/project support or produce a public benefit to El Dorado County?

Wakamatsu Farm is a landmark destination, not only for Japanese and Japanese-Americans, but people of all cultures. As a pilgrimage site, the Farm is now attracting national and international attention along with a growing number of visitors every year. However, still too few people know Wakamatsu Farm exists. WakamatsuFest150 is an attractive and creative way to call the world's attention to an incomparable landmark in El Dorado County. While the festival is a significant event, it is also an investment in the future of Wakamatsu Farm and the surrounding county. The Conservancy will be prepared to host up to 4000 people during the 4day event.

This one-time-only festival will draw the world's attention to El Dorado County's abundant agricultural, natural, and cultural resources. Local, state, national, and international visitors are planning to join WakamatsuFest150. Performers, historians, authors, and others from California, America, and many from Japan are planning to participate in festival activities. Politicians, dignitaries, and religious leaders have been directly invited to the auspicious occasion. To create a successful event, the Conservancy is partnering with local and state organizations, such as the El Dorado Chamber of Commerce, El Dorado County Office of Education, and California State Parks. More than 6 months from the event, festival sponsors already include the Japanese American Citizens League, California Rice Commission, Gekkeikan-Sake, and Weyerhaueser. All WakamatsuFest150 sponsors, participants, and visitors are bringing actual dollars, tourism trade, and new potential economic opportunities to El Dorado County.

Re: 150th Anniversary of the Wakamatsu Tea and Silk Colony and Japanese-American Culture

Dear Supervisor Ranalli,

I want to thank you and the other Supervisors for the opportunity to address the Board on October 16th about the Wakamatsu Fest 150 which will occur over four days, from June 6-9, 2019 at the Wakamatsu Tea and Silk Colony Farm.

We expect this festival and open house will host 4,000 visitors from Japan and across the United States including musicians and other performing artists, academics and enthusiasts of Japanese American culture and history. I think all in El Dorado County should be proud that Gold Hill was selected as the site of the first Japanese agricultural colony in the United States.

The American River Conservancy (ARC) expects the budget for this festival will approximate \$250,000. ARC has already received over \$110,000 in grant and sponsorship funding including small grants from the Consul General of Japan and our "sister cities" of Warabi and Aizu, Wakamatsu.

ARC respectfully requests a matching, small grant from El Dorado County in the amount of \$10,000 to assist with the costs of hosting several historians and academics, possibly including members of the Tokugawa and Matsudaira families during the four (4) day event.

We would also request the presence of the five members of the Board of Supervisors or some representative subset to participate in the planting of a friendship, cherry tree on Saturday, June 8, the exact day the Colony was established in 2019.

Either Melissa Lobach or I would be more than happy to provide an update to the Board of Supervisors during the early spring of 2019 once the schedule of events has been finalized Thank you for your consideration of this request.
