FIRST AMENDMENT TO MASTER RENTAL AGREEMENT FOR EQUIPMENT RENTALS #273-O1811

THIS FIRST AMENDMENT to that Master Rental Agreement for Equipment Rentals #273-O1811 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Holt of California, a corporation duly qualified to conduct business in the State of California, whose principal place of business is 7310 Pacific Avenue, Pleasant Grove, California 95668, whose mailing address is Post Office Box 10001, Sacramento, California 95813 and whose local business address is 8900 Fruitridge Road, Sacramento, California 95826 (hereinafter referred to as "Lessor");

RECITALS

WHEREAS, Lessor has been engaged by County to provide various types of equipment rentals for the Department of Transportation pursuant to Master Rental Agreement for Equipment Rentals #273-O1811, dated February 6, 2018, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$200,000, amending **ARTICLE III, Compensation**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Lessor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

- I. All references to Community Development Services, Department of Transportation, throughout the Agreement shall read Department of Transportation.
- II. **ARTICLE III, Compensation**, fourth (4th) paragraph of the Agreement is amended to read as follows:

The total amount of this Agreement shall not exceed \$400,000.00, inclusive of all costs and expenses.

Except as herein amended, all other parts and sections of Master Rental Agreement for Equipment Rentals #273-O1811 shall remain unchanged and in full force and effect.
