

## **Proclamation** of the El Dorado County Board of Supervisors

## HONORING MICHAEL CICCOZZI FOR HIS EXEMPLARY SERVICE TO EL DORADO COUNTY

**WHEREAS,** Mike left Pennsylvania, where he'd graduated cum laude with a degree in economics from Kings College, to attend Southwestern Law School in Los Angeles, graduating in 1987; and

**WHEREAS,** the beautiful prosecutor he met and married in Los Angeles accepted a job at the El Dorado County District Attorney's office in 1996, resulting in Mike joining the Sacramento area legal community; and

WHEREAS, Mike immediately impressed his coworkers, clients, and supervisors with his sharp legal mind, joyous laugh, cooperative and conscientious work ethic, "can do" attitude and enthusiastic, if not always on key, whistling in the halls; and

**WHEREAS,** Mike saddened his coworkers and colleagues in 2004 when he first attempted to leave them and return to private practice, causing them to cajole, beg and ultimately convince him to return to the office in 2005; and

**WHEREAS,** Mike's excellent representation of a wide array of clients including Human Resources, Child Protective Services, Mental Health, AQMD, Environmental Management, the Assessor and other clients, including many complex matters, caused Mike to be promoted to Senior Deputy in 2012; and

**WHEREAS,** in 2015, Mike's dedication to the County and his wide-ranging experience resulted in him being offered, and accepting a job as Acting Assistant Chief Administrative Officer, causing his coworkers at County Counsel to yet again mourn his loss, but enabling a wide variety of additional County employees to appreciate his hard work, wisdom and humor, and to endure, we mean *enjoy*, his whistling; and

WHEREAS, Mike has spent the last three years calmly and ably guiding the Board and the County departments through their most difficult legal challenges with his good humor; and

WHEREAS, Mike has now accepted a job to lead the County Counsel's office in Yuba County; and
