July 2015-July 2018

Rate Factors:

- Cases Start of Supervision in 3 Year Period
- Based on New Conviction Event
- Based on Violation Event – Outcome with a Conviction Selected
- New Court Case with a Conviction Charge

July 2015-March 17, 2019

All Cases that started July 2015 through March 17, 2019

- 2011 represents only 6 months, July-December
- 2019 represents January – March 17, 2019

Supervision Cases by Age by Type of Case

All Cases that started July 2015 through March 17, 2019

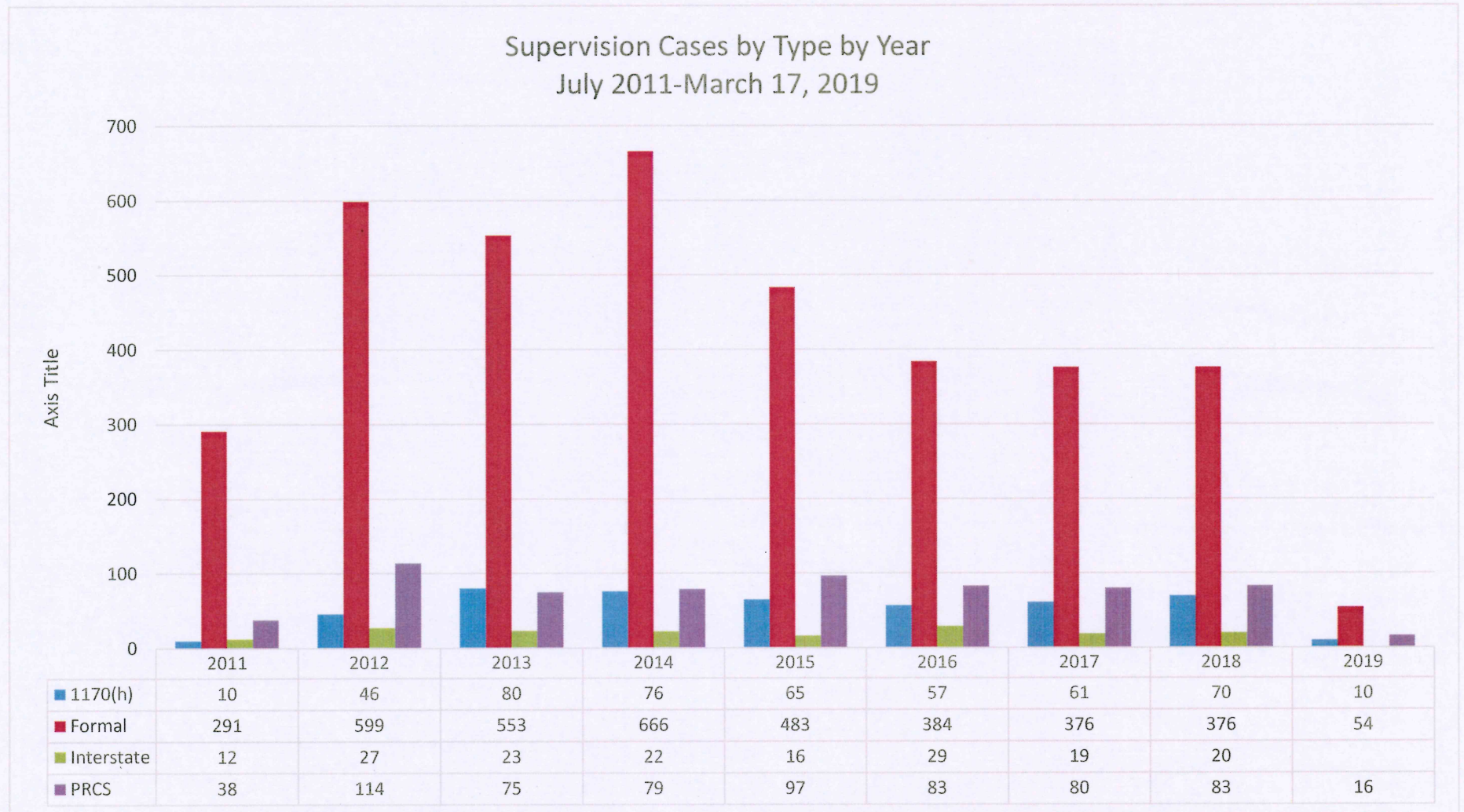
