# STAFF REPORT -APPLICATION FOR THE CONSOLIDATION OF<br/>RIVER USE PERMIT #59 and #60

APPLICANTS:	Mike Miltner, owner of Tahoe Whitewater Tours, which holds River Use Permit #59 and #60.
<u>REQUEST</u> :	Mike Miltner, owner of Tahoe Whitewater Tours, requests the consolidation of River Use Permit #59 and #60 into a single River Use Permit.

#### **SUMMARY RECOMMENDATION:**

Staff recommends your Commission approve the request by Mike Miltner for the consolidation River Use Permit #59 and #60 into a single River Use Permit.

# **BACKGROUND**:

River Use Permit consolidations by an existing outfitter require one approval by your Commission. With the consolidation of the permits the user days will transfer to a single permit #60. The El Dorado County River Management Plan (RMP) contains Element 6.2.1.4 (Exhibit A), which describes the guidelines and procedures for the transfer and consolidation of River Use Permits.

#### **<u>River Use Permit Status</u>**

Tahoe Whitewater Tours is in good standing and has no outstanding fees or unresolved violations.

#### **DISCUSSION**:

#### **Consolidation Requirements**

The applicant for the consolidation has complied with the requirements for a River Use Permit consolidation found in River Management Plan Element 6.2.1.4.1:

- The owner has signed a letter of intent.
- There are no outstanding debts or violations.
- A payment of a \$150 transfer fee has been paid.

# California Environmental Quality Act (CEQA)

The consolidation of an El Dorado County River Use Permit is CEQA exempt under Section 15061(b) (3). There is certainty that the consolidations of River Use Permits will not have a significant effect on the environment. A River Use Permit consolidation does not change the allotted amount of river use allowed by the County's River Management Plan.

#### **FINDINGS**:

1. The application for the consolidation of River Use Permit #59 and #60 into a single River Use Permit meets the standards required by River Management Plan Element 6.2.1.4.
