Dear Chair Novasel and Board of Supervisors,

On Thursday, April 18, 2019, my father presented the Department of Transportation with a proposal in good faith toward reconciliation of the Country Club Drive Realignment matter. I hand delivered copies of this proposal to your offices on Friday, April 19, 2019 and hope that by now you have received and reviewed my father's proposal.

In an effort to continue negotiations with your staff to find an acceptable compromise and settlement of this matter, I would like to respectfully ask for a short postponement of the Resolution of Necessity hearing scheduled for tomorrow, April 23, 2019.

By submitting a proposal with reconciliatory intent, it is our hope to be able to reach an agreement with the Department of Transportation. If it is the Board's intent to proceed with the Resolution of Necessary tomorrow, our efforts to resolve this matter outside of litigation, and with the public's interest in mind, may be limited.

In the spirit of cooperation and respect to the Board, a short postponement would be greatly appreciated. A brief delay, which will prejudice no one, will allow the parties to reconcile and engage in good faith and unconditional negotiation.
