Thank you for providing that information. I have looked through the documents and it seems that you have done good, hard work trying to make the digital sign palatable. However, I believe that bright lit signs have no place in our County and will erode the rural beauty of our viewscape. I have also found them to be dangerously distracting on occasions when I was driving.

I regret that my job will keep me from attending the meeting in person, but I will submit a letter hopefully tomorrow against the project - not because of your work, but because these signs in my opinion should be illegal everywhere and should certainly not come in to El Dorado County. If this one were approved, I worry that it will open the door to more signs and eventually more brightness. I hope to never see that day. So few places now have roads with views of trees and nature — that promote mental health as well as look nice — that we should hold on to this valuable aspect of our County. It helps our selves, our wildlife, and our tourist dollars too.


