

AGREEMENT FOR SERVICES #2454 AMENDMENT I

This Amendment I to that Agreement for Services #2454, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Aegis Treatment Centers, LLC, a Delaware Limited Liability Company, duly qualified to conduct business in the State of California, whose principal place of business is 7246 Remmet Avenue, Canoga Park, CA 91303; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide Narcotic Treatment Program (NTP) Services in accordance with County of El Dorado Drug Medi-Cal Agreement #220-F1811 with the State of California administered by the Department of Health Care Services (DHCS) which requires County to provide eligible El Dorado County Medi-Cal beneficiaries with a continuum of drug and alcohol prevention and treatment services on an "as requested" basis, in accordance with Agreement for Services #2454, dated July 17, 2018, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of said Agreement, hereby amending ARTICLE II – Term; and

WHEREAS, the parties hereto have mutually agreed to amend ARTICLE XXVII – Administrator and ARTICLE XV – Notice to Parties; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #2454 shall be amended a First time as follows:

1) Article II is hereby amended in its entirety to read as follows:

ARTICLE II

Term: This Agreement, as amended, shall become effective upon final execution by both parties hereto and shall cover the period of July 17, 2018 and expire June 30, 2021 unless terminated earlier pursuant to the provisions contained herein under the Article(s) titled "Default, Termination, and Cancellation" or "Fiscal Considerations."

2) Article XXVII is hereby amended in its entirety to read as follows:

ARTICLE XXVII

Administrator: The County Officer or employee with responsibility for administering this Agreement is Salina Drennan, Substance Use Disorder Services Program Manager, or successor.

3) Article XV is hereby amended in its entirety to read as follows:

ARTICLE XV

Notice to Parties: All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to County shall be addressed as follows:
