# **ECONOMIC DEVELOPMENT UPDATES**

Tiffany Schmid, Director of Planning and Building, gave a brief update on the following economic development items:

- 1. Introduced Katie Rider, Department Analyst/Ombudsman;
- 2. The Administrative Assistant position has been filled. Amelia Pedri will start on April 29, 2019;
- 3. Final interviews for Senior Department Analyst will be held on April 12, 2019;
- 4. There is a Special Budget Board meeting on Monday, April 22, 2019;
- 5. Greater Sacramento Economic Council (GSEC) will present at the regular Board meeting on Tuesday, April 23, 2019;
- 6. Isabel Domeyko from New Economics Advisory, will give a presentation to the Board on Tuesday, April 30, 2019 on the Apple Hill/Camino Economic Impact Study that was recently completed; and,
- 7. The County continues to work on a Strategic Plan Update.

## **CEDAC MEMBER UPDATES**

Member Wood sits on the Fire Emergency Services Committee and recently visited the Camino Dispatch Center. She announced to the Committee that the Cameron Park Summer Spectacular event will be held on June 29, 2019.

She also spoke with 3rd and 4th grade teachers at Georgetown Elementary. The students have been learning local history and interviewing local businesses.

Member Wofford thanked Tiffany Schmid and Kyle Zimbelman and welcomed Katie Rider to the County. She recently attended the I Love Film Mixer, Cameron Park Luau and the El Dorado Wine Association's Passport Weekend. She announced to the Committee that Farm Day will be held on May 7th.

Member Reinhardt updated the Committee on his job search.

Member Bernstein expressed how he is always impressed with the level of conversation that is held during CEDAC meetings.

Member Payne reminded the Committee that he sits on the El Dorado County Park and Recreation Commission. He is also a Member of the El Dorado County Historical Society. They are hosting the California Historical Society in conjunction with the Visitor's Authority on June 20, 21 and 22nd. He also shared that Diamond Springs/El Dorado is working on design standards.
