Subject: Health and Human Services Agency Public Guardian Division Request to Process the Attached Budget Transfer

The Health and Human Services Agency (HHSA), Public Guardian Division (PG), is requesting a budget transfer to increase appropriations to Other Governmental Agencies and to also draw down funds from the Audit Reserves that the CAO established in Dept. 15 in November of 2016. The reserve was in the amount of \$240K, of which \$59K was used in FY 2017-18 to pay a FY 2011-12 TCM cost report audit settlement. Due to a recent FY 2014-15 TCM site visit audit settlement, HHSA is required to pay back \$37K for revenue that was received and disallowed during the audit. The audit reserve balance should be more than sufficient to support this transfer.
