### I. PURPOSE

- c. Provide case management services in a timely manner to best address the needs of homeless clients.
- d. Provide the administrative and evaluative support necessary to implement the aforementioned services and collaborative efforts.
- e. Work collaboratively to improve the quality of life and be of service to the residents of the neighborhood in which the facility is located, as well as to all others in the community, including qualified and prescreened homeless women, men and children

f. Agree, to the fullest extent permitted by law, to defend, indemnify and hold harmless JOB ONE, and its employees, officials, and agents, from and against any and all claims, liability, loss, or injury, directly or indirectly, arising from or related to any activity of UOEDC, and/or its officials, employees, or agents, under this MOU, but only to the extent that any of the above are actually caused by the negligent act or omission or intentional misconduct of UOEDC or its officials, employees, or agents. The obligations of this provision of the MOU shall survive termination or expiration of this MOU.

### 3. JOB ONE agrees to:

- a. Meet with UOEDC to review case files and identify appropriate job seeker services one day per month
- b. The aforementioned services shall be provided in a timely manner to best address the needs of homeless clients.

Agree, to the fullest extent permitted by law, to defend, indemnify and hold harmless UOEDC, and its employees, officials, and agents, from and against any and all claims, liability, loss, or injury, directly or indirectly, arising from or related to any activity of JOB ONE, and/or its officials, employees, or agents, under this MOU, but only to the extent that any of the above are actually caused by the negligent act or omission or intentional misconduct of JOB ONE or its officials, employees, or agents. The obligations of this provision of the MOU shall survive termination or expiration of this MOU.

If either party to this MOU institutes or is required to defend any legal proceeding, action or motion to enforce or interpret the terms of this MOU, the prevailing party shall be entitled to recover all associated costs and expenses, specifically including, but not limited to, reasonable attorney's fees.

UOEDC shall, at its sole cost and expense, obtain and keep in force throughout the term of this MOU a policy of commercial general liability insurance with liability limits of not less than One Million Dollars (\$1,000,000) general aggregate and One Million Dollars (\$1,000,000) per occurrence, insuring against all liability of JOB ONE, and its officials, employees and agents, for personal injury or death or property damage arising out of or in any way connected with any of UOEDC's or its officials', employees', or agents', activities under this MOU. Mrs. Aldrich:

Thank you for submitting the 501(c)(3) letter for United Outreach of El Dorado County. Under Section 16100 of the California Business and Professions Code and El Dorado County Environmental Management Department Policy 100-41, the United Outreach shelter is exempt from food facility fees. This includes the standard plan check fee of \$625 for public agencies, the \$125 hourly plan check fee for building remodels, and the \$375 fee for the annual health permit.

The United Outreach shelter will still be required to undergo plan review prior to construction and will also be required to have bi-annual inspections of the kitchen facilities by this Department. According to the California Retail Food Code, each food facility must have at least one person that has passed a food safety certification examination. Food safety courses and examinations are offered through the El Dorado County Environmental Management Department, but are not exempt from standard fees.

Dear Gayle:

The El Dorado County Public Health Department is able to provide the following by way of services to the clients of the proposed homeless shelter:

- 1. Communicable disease services: These include immunizations, and screening and education around sexually transmitted diseases, blood-borne pathogens and tuberculosis.
- 2. Enrollment of children in health insurance through the Children's Health Initiative: This would include on-site appointments for families with children who do not have health insurance to determine eligibility. Assistance would also be provided to families in need of finding a medical or dental home for their child(ren) on a case-by-case basis. Once per month we could also provide education regarding the importance of utilizing a medical and/or dental home for primary, preventive and urgent care needs.
- 3. Tobacco prevention: Tobacco program staff can provide cessation resources and referrals to cessation services for clients as needed.
- 4. Child passenger safety seat education: Education and car seat installations can be offered to families with incomes under 200% of the Federal Poverty level.
- 5. Drug and alcohol education: Our staff could provide educational groups focused on substance abuse, STD/HIV/hepatitis C education and support, alcohol and drug assessments, and linkages to Cal-WORK's and dependency drug court.
- 6. Public health nursing: Services to families with children or pregnant/postpartum women could be offered, including health/nutrition education, parenting skill development, breastfeeding, formula preparation, specialty care referral and general monitoring i.e., failure to thrive, response to treatment etc. A public health nurse could also be available on call to provide general pediatric/adult triage in possible non-acute CPS or APS situations.

Overall, the Department of Public Health is ready to provide 4 to 6 hours per week, either on-site or at other appropriate locations, including our Placerville clinic. We look forward to serving this vulnerable population, and we are ready to begin services from the moment the shelter opens its doors.

### MEMORANDUM OF UNDERSTANDING

### Between

United Outreach of El Dorado County, a 501(c)(3)

### And

Emerging Hope, a 501(c)(3) Public Benefit Corporation

For

Collaboration and Supportive Services

To Support United Outreach of El Dorado County in Their Efforts to Provide a

Comprehensive Case Management Program for Homeless Clients

This Memorandum of Understanding (MOU) is a supportive services agreement entered into by and between United Outreach of El Dorado County (UOEDC), a 501(c)(3), and EMERGING HOPE. This MOU sets forth each partner's role and responsibilities relative to the case management program available to clients served by UOEDC that are homeless, living in transition or receiving emergency shelter services.

### WITNESSETH

WHEREAS, UOEDC provides emergency shelter and case management services for homeless individuals and families, and

WHEREAS, UOEDC and EMERGING HOPE desire to work in partnership in the design, development, and implementation of collaborative efforts to address the intersection of services for homeless women with children in their care, and

WHEREAS, EMERGING HOPE has the responsibility, experience and expertise to provide supportive services for homeless women with children in their care,

**NOW, THEREFORE, UOEDC** and EMERGING HOPE mutually agree as follows:

### I. PURPOSE

The purpose of this Memorandum of Understanding, hereinafter referred to as MOU, is to establish a cooperative working relationship among the parties and to define roles and responsibilities with respect to providing case management and supportive services to homeless women with children in their care.

### II. TERM OF AGREEMENT

The MOU shall be effective upon execution by all parties and shall remain in effect until terminated by written notification by either party to the Agreement. Either party may terminate this Agreement for any reason upon thirty (30) days written notice to the other party.

### III. SCOPE OF SERVICES

### 1. Mutual Responsibilities:

- a. Collaborate in the identification and referral of appropriate clients for services.
- b. Collaborate to determine the duration of services and communicate ongoing needs of clients to ensure the development of skills necessary to achieve and maintain self-sufficiency. (For those individuals who qualify for our services the full spectrum of services is already in place to provide services to ensure a future goal for maximum self-sufficiency as the woman with children in her care is capable of being responsible)
- c. Establish mutually satisfactory methods for the exchange of such information as may be necessary in order that each party may perform its duties and functions under this MOU; and ensure appropriate and proper procedures are utilized to ensure that all information shall be safeguarded from improper disclosure in accordance with applicable state and federal laws and regulations.
- d. Comply with all applicable federal, state and local laws.

### 2. UOEDC agrees to:

- a. Operate and administer a program providing emergency shelter services to homeless persons in El Dorado County.
- b. Provide comprehensive case management services and interventions to homeless persons, including assistance in gaining access to other supportive services beneficial to gaining self-sufficiency.
- c. Provide case management services in a timely manner to best address the needs of homeless clients.
- d. Provide the administrative and evaluative support necessary to implement the aforementioned services and collaborative efforts.
- e. Work collaboratively to improve the quality of life and be of service to the residents of the neighborhood in which the facility is located, as well as to all others in the community, including qualified and prescreened homeless women, men and children.
- f. Agree, to the fullest extent permitted by law, to defend, indemnify and hold harmless EMERGING HOPE, and its employees, officials, and agents, from and

against any and all claims, liability, loss, or injury, directly or indirectly, arising from or related to any activity of UOEDC, and/or its officials, employees, or agents, under this MOU, but only to the extent that any of the above are actually caused by the negligent act or omission or intentional misconduct of UOEDC or its officials, employees, or agents. The obligations of this provision of the MOU shall survive termination or expiration of this MOU.

### 3. EMERGING HOPE agrees to:

- a. Partner with UOEDC in providing services for any homeless women with children in their care. Contacts will be Shannon Bezak at (530)622-3231 x242. We will either connect individuals with the proper organization for services or complete a quick assessment to determine which services might be most immediately beneficial to the woman with children in their care. Any prior coordination and planning between EMERGING HOPE and UOEDC for referral process and information will follow our standard process already in place.
- b. The aforementioned services shall be provided in a timely manner to best address the needs of homeless women with children in their care, who qualify for our services.
- c. Agree, to the fullest extent permitted by law, to defend, indemnify and hold harmless UOEDC, and its employees, officials, and agents, from and against any and all claims, liability, loss, or injury, directly or indirectly, arising from or related to any activity of EMERGING HOPE, and/or its officials, employees, or agents, under this MOU, but only to the extent that any of the above are actually caused by the negligent act or omission or intentional misconduct of EMERGING HOPE its officials, employees, or agents. The obligations of this provision of the MOU shall survive termination or expiration of this MOU.
- d. Attend community meetings or share the message of the importance of this project to the homeless women with children in their care who want and need such services.

### IV. COMPENSATION

For the purposes of this Agreement, no compensation shall be exchanged by either party.

### V. MODIFICATION

This MOU may be amended by mutual consent of the parties hereto. Said amendments shall become effective only when in writing and fully executed by duly authorized officers of the parties hereto.

### VIII. TIME IS OF THE ESSENCE

Time is hereby expressly declared to be of the essence in this Agreement and of each and every provision hereof, and each such provision is hereby made and declared to be a material, necessary, and essential part of this Agreement.

### IX. NO INCIDENTAL DAMAGES, etc.

Notwithstanding any other provisions of this MOU, in no event shall either party be liable, regardless of whether any claim is based on contract or tort, for any special, consequential, indirect or incidental damages arising out of or in connection with any activity under this MOU.

### X. ATTORNEY'S FEES

If either party to this MOU institutes or is required to defend any legal proceeding, action or motion to enforce or interpret the terms of this MOU, the prevailing party shall be entitled to recover all associated costs and expenses, specifically including, but not limited to, reasonable attorney's fees.

### XI. INSURANCE

UOEDC shall, at its sole cost and expense, obtain and keep in force throughout the term of this MOU a policy of commercial general liability insurance with liability limits of not less than One Million Dollars (\$1,000,000) general aggregate and One Million Dollars (\$1,000,000) per occurrence, insuring against all liability of EMERGING HOPE, and its officials, employees and agents, for personal injury or death or property damage arising out of or in any way connected with any of UOEDC's or its officials', employees', or agents', activities under this MOU. UOEDC shall be solely responsible for payment of all deductibles. EMERGING HOPE and its officials, employees and agents, shall be named as additional insured under such policy by policy endorsement. Within thirty (30) days of

the effective date of this MOU, UOEDC shall provide EMERGING HOPE with a certificate of insurance and policy endorsement evidencing UOEDC's compliance with the requirements of this provision of the MOU. Written notice of cancellation or non-renewal of said policy shall be mailed to EMERGING HOPE thirty (30) days in advance of the effective date thereof.

EMERGING HOPE shall, at its sole cost and expense, under an umbrella policy held by Green Valley Community Church, obtain and keep in force throughout the term of this MOU a policy of commercial general liability insurance with liability limits of not less than One Million Dollars (\$1,000,000) general aggregate and One Million Dollars (\$1,000,000) per occurrence, insuring against all liability of UOEDC, and its officials, employees and agents, for personal injury or death or property damage arising out of or in any way connected with any of EMERGING HOPE's or its officials', employees', or agents', activities under this MOU. EMERGING HOPE shall be solely responsible for payment of all deductibles. UOEDC, and its officials, employees and agents, shall be named as additional insured under such policy by policy endorsement. Within thirty (30) days of the effective date of this MOU, EMERGING HOPE shall provide UOEDC with a certificate of insurance and policy endorsement evidencing EMERGING HOPE's compliance with the requirements of this provision of the MOU. Written notice of cancellation or non-renewal of said policy shall be mailed to UOEDC thirty (30) days in advance of the effective date thereof.
