Hello Joyce:

In answer to your questions: 1) the term of the lease requirement under CDBG (what is the definition of 'long term)?; and 2) can the facility component pay the full lease period prior to expiration of the grant term?

- #1. Per HUD's State Community Development Block Grant Program, Guide to National Objectives and Eligible Activities for State CDBG Program, long term is "....a lease period of 15 years or more..." anothered? - #2. After further consideration, discussion with staff, review of CDBG resources, and consultation with HUD, it was determined that the Intent to Lease is eligible under Public Facilities only when it is considered acquisition. To be considered acquisition, it must meet the following conditions:
 - The lease must be for a period of 15 years or more;
 - Payment must be paid up front in a lump sum lease payment equal to the appraised value of the leasehold interest.

Please note that monthly payment of a lease is considered an operational cost and is not eligible under public facilities activities.

Thank you for your response to the items discussed with Anda last week. I do however have a question on the Lease simply because the original application and location was intended to be a lease as well and the Intent to Lease was submitted as part of the application. In that case, the question wasn't whether United Outreach could lease a site, but rather if the CDBG funds could pay the required period of time that the CDBG regulations require the length of time the lease must be for. Therefore the questions were:

Hello Joyce:

Anda has asked me to follow-up to questions as a result of the conference call last week; I am sorry I was not available.

I have attached a sheet that provides the scoring breakdown for the County. Please take note to the scores highlighted in red (i.e., need, leverage, capacity and readiness); these scores in particular can change based on whether the documentation provided for the new site is comparable to the initial application.

Further, please follow the appropriate process for public notices, hearings, and citizen participation .

In regard to utilizing CDBG funds to pay lease payments for the land (ground lease); based on the fact that the activity in your application is explicitly a public facility, and we are considering just a change in site of the project, in order to maintain comparability, the use of CDBG funds for this type of expense is not allowed.

To request permission to incur costs on general administration activities prior to receiving an executed contract, please submit a formal written request to my attention. However, please be advised that no funds CDBG or otherwise can be spent on the actual activity until NEPA process is completed and written approval received by the Department.
