

RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, Resolutions #187-2009, #198-2009, and #221-2009, adopted by the Board on August 11, 2009 and August 25, 2009, and September 29, respectively, incorrectly referenced Resolution #159-2009 as the authorized personnel allocation based on the Proposed Budget;

WHEREAS, Resolution #221-2009, modifying the authorized personnel allocation based on the FY 2009-10 Final Budget did not incorporate modifications that had been made through Resolutions #187-2009 and #198-2009; and

WHEREAS, The Board approved a reduction of 0.29 FTE Program Aide (vacant) to the personnel allocation for the Department of Human Services in open session during hearings for the FY 2009-10 Final Budget which was inadvertently omitted from Resolution #221-2009;

NOW, THEREFORE, BE IT RESOLVED that all references to Resolution #159-2009 in Resolutions #187-2009, #198-2009, and #221-2009 shall be replaced with Resolution #158-2009;

BE IT FURTHER RESOLVED that modifications to Resolution #158-2009 as a result of the adoption of Resolutions #187-2009 and #198-2009 are hereby incorporated; and

BE IT FURTHER RESOLVED that Resolution #158-2009 is to be further modified to reflect the Board's direction to delete 0.29 FTE Program Aide in the Human Services Department, and the authorized personnel allocation for the Human Services Department as of September 29, 2009 is set forth as attached hereto
