ARTICLE XII. - FISH AND GAME COMMITTEE

Sec. 2.20.820. - Established.

There is created and established a citizens' advisory committee consisting of five or seven members to be known as the County Fish and Game Committee.

Sec. 2.20.830. - Appointment.

One member of the County Fish and Game Committee shall be appointed by the Board of Supervisors from each of the supervisorial districts in the County upon the nomination of the supervisor representing the district. Each member shall be a resident of the supervisorial district which he or she represents on the Committee. In addition to the five members so appointed, the Board of Supervisors may appoint two members who shall represent the County at large and shall serve at the pleasure of the Board.

Sec. 2.20.840. - Term of office.

Each of the five members of the County Fish and Game Committee appointed from a supervisorial district shall hold office for a period of four years to coincide with the term of office of the supervisor who nominates the member for appointment. The term of office of each member of the County Fish and Game Committee shall be as prescribed by Section 2.20.010. Vacancies shall be filled in the same manner as the original appointment for the unexpired portion of the term.

Sec. 2.20.850. - Officers.

The County fish and game committee shall elect from their own number a chairman who shall preside at all meetings of the committee, a vice chairman who shall perform the duties of the chairman in his absence, and a secretary who shall keep a record of the proceedings of the committee.

Sec. 2.20.860. - Rules of procedure.

The Fish and Game Committee shall adopt bylaws providing for the dates for regular meetings of the Committee and such other rules as may be necessary for the transaction of its business.

Sec. 2.20.870. - Powers and duties.

The Fish and Game Committee shall:

A. Advise the Board of Supervisors on matters affecting the conservation of fish and game within the jurisdiction of the Board of Supervisors;

- B. Make recommendations to the Board of Supervisors regarding the expenditure of the Fish and Game Fund of the County;
- C. Perform such other duties and functions as the Board of Supervisors may direct;
- D. Prepare a detailed budget for proposed expenditures during each fiscal year;
- E. In its discretion by majority vote, authorize the Committee Chair to expend funds within the approved budget, except for expenditures relating to personnel.
