We would like to submit our concerns regarding the proposed El Dorado Senior Resort. While we do recognize the need for more senior living services and dwellings in our county we are STRONGLY OPPOSED to the plan as its described in the proposal.

1.) Access ONLY to the development via Koki Lane is extremely problematic. Koki Lane is the only thoroughfare to the Dorado Woods neighborhood and the main entrance to Union Mine High School. With one signal light at the entrance to Koki Lane, existing traffic is already at capacity and significantly backed up during morning and afternoon school hours not to mention evening and weekend school activities, sporting events and meetings. Adding an access only road leading to the proposed development via Koki would have an egregious impact on this already problematic passageway.

2. The complete removal of trees and stripping of vegetation would have a huge impact on the flooding issues that are long standing in this county particularly in this area.

3.) Proposed elevated 2 and 3 story buildings along with the deforestation will be an enormous deficit to the aesthetics, privacy and property values for the home owners of the surrounding area.
