FIRST AMENDMENT TO AGREEMENT FOR SERVICES #2969

THIS FIRST AMENDMENT to that Agreement for Services #2969 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Joe Vicini, Inc., a corporation duly qualified to conduct business in the State of California, whose principal place of business is 315 Placerville Drive, Placerville, California 95667 (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide on-call road zone maintenance services for the Department of Transportation pursuant to Agreement for Services #2969, dated June 1, 2018, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$250,000, amending Article 4, Contract Price;

WHEREAS, the parties hereto desire to update County's notice recipients, amending Article 47, Notice;

WHEREAS, the parties hereto desire to update County's Contract Administrator, amending Article 53, Contract Administrator;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

- I. All references to Community Development Services, Administration and Finance Division, throughout the Agreement shall read Department of Transportation.
- II. Article 4, Contract Price, the second paragraph of the Article is amended in its entirety to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$500,000, inclusive of all Task Orders, Work Orders, costs, and expenses.

III. Article 47, Notice, of the Agreement is amended in its entirety to read as follows:

47. Notice

Any notice or other correspondence required to be given under this Agreement by either party to the other may be affected by personal delivery in writing or by mail, postage prepaid. Notices personally delivered during normal business hours shall be deemed received on the actual date of delivery; mailed notices shall be deemed received one (1) day after affixed postmark. 53. Contract Administrator

The County Officer or employee with responsibility for administering this Agreement is Matthew Smeltzer, P.E., Deputy Director, Engineering, Fairlane Engineering Division, Department of Transportation, or successor.

Except as herein amended, all other parts and sections of Agreement for Services #2969 shall remain unchanged and in full force and effect.
