However, our past experience with previous residences where the infrastructure was in place before the development, did not prepare us for the debacle that the current residents of Bass Lake Road face today.

With the planned Bass Lake Hills Specific Plan infrastructure concurrency objective set aside to be constructed by as yet unnamed future developments and Parker Development closing out their last development, Serrano Village J7, without the improvements to Bass Lake Road that were included in the original documents in 2007, how many more years will it be before the road will be improved?

Woodridge has a left turn only lane and Bridlewood Canyon lacks both turn lanes which creates a substantial safety hazard for the residents and over the years there have been many accidents as a result. This can be verified by the comment letter from the Bass Lake Action Committee which contains a CHP Incident Report reflecting 73 collisions actually reported from 2009 – 2019 between Woodleigh and Bridlewood Canyon. The largest shares of the incidents were at Madera and Bridlewood Canyon and all prior to the new residential development, commercial businesses and proposed Bass Lake Regional Park.

On a personal note, my husband was involved in a collision in which he was not at fault while turning left into Bridlewood Canyon in 2010. His vehicle was hit by a car which was exiting and my belief is that if there had been a left turn lane the accident could have been averted. This is one of several incidents we are aware of that are not reflected in the CHP Report.

The construction of Silver Springs Parkway, when and if it happens, is supposed to provide WoodRidge with a right hand turn lane but Bridlewood Canyon was not included in this project.

With the completion of the El Dorado Hills Community Services District proposed Bass Lake Park which will include a 500 car parking lot on the south side of Bass Lake and a 100 car parking lot on the north side, the developments in the immediate area both new and old will be significantly impacted by the increased traffic.

The stretch of road between Madera and Sienna Ridge will be quite congested with four development entrances on one side and the proposed Bass Lake Park entrance on the west side. Residents of the Bridlewood Canyon community should be able to safely leave and enter their development as should all the occupants of the area. They will be further affected by the fact that the Serrano Village J7 entrance is very near their own. At the very least, Bridlewood Canyon should have a left and right turn lane constructed as originally proposed in the Conditions of Approval in 2007 for Serrano Village J or another method for safety purposes.
