On **September 12, 2019**, the Planning Commission will hold a public hearing to consider the boundaries of the proposed Weber Creek Canyon Important Biological Corridor (IBC) Your parcel (APN: xxx-xxx-xxx) has been identified as one of the properties located within the proposed boundaries of the Weber Creek Canyon IBC and would be subject to El Dorado County General Plan Policy 7.4.2.9 which states that:

"In order to evaluate project-specific compatibility with the -IBC overlay, applicants for discretionary projects (and applicants for ministerial projects within the Weber Creek Canyon IBC) shall be required to provide to the County a biological resources technical report. The site-specific biological resources technical report will determine the presence of special-status species or habitat for such species that may be affected by a proposed project as well as the presence of wildlife corridors particularly those used by large mammals such as mountain lion, bobcat, mule deer, American black bear, and coyote. Properties within the -IBC overlay that are found to support wildlife movement shall provide mitigation to ensure there is no net loss of wildlife movement function and value for special-status species, as well as large mammals such as mountain lion, bobcat, mule deer, American black bear, and coyote. Mitigation measures may include land use siting and design tools."
