## **MEMORANDUM**

SUBJECT: Plant and Wildlife Technical Advisory Committee Membership

### **Background:**

On June 10, 2008, your Board directed staff to prepare a recommendation for a combined Plant and Wildlife Technical Advisory Committee (PAWTAC) and stakeholder committee and bring back names and qualifications of those willing to serve on such a committee.

### **Discussion:**

Staff contacted the members of PAWTAC that last served on the committee for the General Plan Update process. One member, Greg Greenwood (representing the California Department of Forestry and Fire Protection), is out of contact, and staff believes that he is living out of the country. The representative from S.A.G.E. (Rick Russell) is no longer president of that organization, and the current president, Dan Hinrichs, has volunteered to serve as replacement. Daniel Burmester and Terri Weist of California Department of Fish and Game are no longer assigned to El Dorado County projects; they have been replaced with Todd Gardner. Similarly, Susan Moore and Lori Rinek of U.S. Fish and Wildlife Service are no longer assigned to PAWTAC; they have been replaced by Amy Fesnock. David Witter (El Dorado Irrigation District) is replaced by Dan Corcoran. There was no response from private consultant Connie Wade of Wade & Associates. The remaining members of PAWTAC replied affirmatively that they wished to continue their roles as PAWTAC members.
