

#### **ORDINANCE NO. 5112**

# AN ORDINANCE ADOPTING AN UPDATE TO TITLE 130 (ZONING ORDINANCE)

## THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS:

**Section 1.** The Board of Supervisors finds and determines that amendments to Title 130 are necessary to update the El Dorado County Ordinance Code to amend the Matrix of Allowed Uses in Article 2 (Zones, Allowed Uses, and Zoning Standards) to identify the zones where the commercial cannabis uses are allowed, subject to a Commercial Cannabis Use Permit.

**Section 2.** Title 130 of the El Dorado County Ordinance Code is hereby amended as follows:
