Dear Board Members:

The attached schedule lists the loans that the general fund made at June 30, 2019 to various other funds at the County. I recommend that you receive and file it.

One matter of considerable concern is that the cash deficit in the Road Fund increased from \$2.4 million at June 2018 to \$5.9 million at June 2019. A significant cause of the Road Fund's cash deficit is an approximately \$12 million receivable from FEMA. If the majority of these funds due from FEMA are not collected by December 31, 2019, there may be significant ramifications for the General Fund Budget.
