WHEREAS, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

WHEREAS, on February 25, 1971, Trans-Land Co., a co-partnership by Land Tech Corporation, an Ohio Corporation, irrevocably offered for dedication public utility easements on Lot numbers 1095, 1096, 1097, 1098 and 1099 as shown on the final map of Auburn Lake Trails, Unit No. 5, recorded in Book E of Subdivisions at Page 85 in the County of El Dorado Recorder's Office; and

WHEREAS, the County of El Dorado has received an application from Robert Jacques and Tessa Jacques, the legal owners of Parcel A of that certain Parcel Map entitled A Merger of Lots 1095, 1096, 1097, 1098 and Lots 1099, 1156, 1157, and 1158 of Auburn Lake Trails Unit No. 5, recorded on August 15, 1985, in Book 34 at Page 57 of Parcel Maps in the County of the El Dorado Recorder's Office, requesting that the County of El Dorado vacate the subject easements of said property, identified as Assessor's Parcel Number 073-241-015; and

WHEREAS, AT&T, Comcast, Department of Transportation, Georgetown Public Utility District, and Pacific Gas & Electric have not used said easement for the purpose for which it was dedicated and find no present or future need exists for subject easement and do not object to its vacation, and to that end, have all issued letters to that effect; and

WHEREAS, the Surveyor's Office has determined that the easements herein described in Exhibit A and depicted on Exhibit B and made a part thereof have not been used for the purpose for which they were dedicated and have no objection; and

WHEREAS, all other existing easements shall remain.

NOW, THEREFORE, BE IT RESOLVED, that from and after the date this Resolution is recorded, said offer for the public utility easements, described in Exhibit A and depicted on Exhibit B, are terminated and abandoned and no longer constitute an offer for easement. In addition, a Certificate Of Correction, Modification or Amendment is hereby authorized to be signed and recorded.
