

AGREEMENT FOR SERVICES #2881 AMENDMENT I

This Amendment I to that Agreement for Services #2881, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Henning Mehrens, M.D., Inc., a California Corporation doing business as Tahoe Urgent Care Medical Clinic, duly qualified to conduct business in the State of California whose principal place of business is 2130 Lake Tahoe Boulevard, South Lake Tahoe, CA 96150 (Mailing: PO Box 2547, South Lake Tahoe, CA 96158) (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide substance abuse testing services, in accordance with Agreement for Services #2881, dated May 29, 2018, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to amend Article IV, "Maximum Obligation, and Article XIII, "Notice to Parties" of said Agreement; and

WHEREAS, the parties hereto have mutually agreed to add the option to sign this Agreement in counterpart, thereby inserting Article XXXIII, "Counterparts."

NOW THEREFORE, the parties do hereby agree that Agreement for Services #2881 shall be amended a first time as follows:

1) ARTICLE IV - Maximum Obligation

ARTICLE IV

Maximum Obligation: The maximum contractual obligation under this Agreement shall not exceed \$180,000.00 for all of the stated services during the term of the Agreement.

2) ARTICLE IV - Notice to Parties
