

## RESOLUTION NO. **152-2017**

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

## RESOLUTION AUTHORIZING SUBMITTAL OF INDIVIDUAL AND REGIONAL GRANT APPLICATIONS FOR WHICH COMMUNITY DEVELOPMENT SERVICES, ENVIRONMENTAL MANAGEMENT DEPARTMENT IS ELIGIBLE

**WHEREAS,** Public Resources Code sections 48000 et seq. authorize the Department of Resources Recycling and Recovery (CalRecycle) to administer various grant programs (grants) in furtherance of the State of California's (State) efforts to reduce, recycle, and reuse solid waste generated in the state thereby preserving landfill capacity and protecting public health and safety and the environment; and

**WHEREAS**, in furtherance of this authority CalRecycle is required to establish procedures governing the application, awarding, and management of the grants; and

WHEREAS, certain grant projects allow regional participation; and

**WHEREAS**, CalRecycle's procedures for administrating grant applications require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of CalRecycle grants; and

WHEREAS, adoption of this resolution will supercede Resolution 043-2015.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado authorizes the Community Development Services, Environmental Management Department to submit applications to CalRecycle on behalf of itself as Lead Agency and the participating jurisdictions shown in Exhibit A; and

**BE IT FURTHER RESOLVED** that the Director of the Environmental Management Department, or his/her designee, is hereby authorized and empowered to execute on behalf of Community Development Services, Environmental Management Department all grant-related documents, including, but not limited to, applications, payment requests, agreements, and amendments necessary to secure grant funds and to implement the approved grant project; and

**BE IT FURTHER RESOLVED** that these authorizations are effective for five (5) years from the date of adoption of this resolution or until rescinded by the Board of Supervisors, whichever comes first.
