## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

## RESOLUTION TO FORM WESTERN SLOPE CEMETERY ZONE OF BENEFIT WITHIN COUNTY SERVICE AREA NO. 9

WHEREAS, the Board of Supervisors of the County of El Dorado has formed County Service Area No. 9 pursuant to Title 3, Division 2, Part 2, Chapter 2.2 of the California Government Code; and

WHEREAS, the Board adopted the County of El Dorado Policy and Procedure Guidelines for Creation and Administration of Zones of Benefit within a County Service Area, as amended June 2, 1987 and February 10, 2015, which provides that the Board shall adopt a resolution of intention to form a zone of benefit pursuant to Article 8 of Title 3, Division 2, Part 2, Chapter 2.5 of the Government Code; and

WHEREAS, Government Code §25217 (b) expressly authorizes the Board to initiate proceedings to form a zone of benefit by following the procedures set forth in §§ 25217 and 25217.1; and

WHEREAS, the Board, acting as the Governing Body of County Service Area No. 9 finds that it is in the public interest to form the Western Slope Cemetery Zone of Benefit, the boundaries of which consist of the boundaries of County Service Area No.9 (save and except for those properties within the existing Kelsey Cemetery District, Happy Homestead Cemetery District, Georgetown Cemetery Zone of Benefit, City of Placerville, or County Service Area 3) for the purpose of providing a higher level of service in cemetery operations, maintenance, historical preservation and capital improvement by raising additional revenue through a special tax pursuant to section 25215.2 of the Government Code; and

WHEREAS, notice of the public hearing to consider formation of the zone was given to all interested parties pursuant to Government Code 25217(d) and the Board having determined that a majority protest to formation of the zone of benefit does not exist; and

## NOW, THEREFORE, BE IT RESOLVED as follows:

- Authority. The board hereby forms the Western Slope Cemetery Zone of Benefit within County Service Area No. 9 pursuant to Article 8 of Title 3, Division 2, Part 2, Chapter 2.5 of the California Government Codes subject to voter approval of the special tax funding said district. Should the special tax fail to receive the necessary votes to pass said zone of benefit shall not be formed.
  - **Boundaries.** The boundaries of the zone are established as the existing boundaries of County Service Area No.9 (exempting those properties within the existing Kelsey Cemetery District, Happy Homestead Cemetery District, Georgetown Cemetery Zone of Benefit, City of Placerville and County Service Area 3)
- 3 <u>Reason for Formation.</u> The zone of benefit is being formed in order to provide different and better levels of service in the operation, maintenance, and historical preservation, and capital improvements of the public cemeteries within the proposed zone.
- 4 <u>Services.</u> The services provided shall be the operation, maintenance, and historical preservation of the public cemeteries, including capital replacement and improvements.
- Financing. The cemetery operation, maintenance, and historical preservation including capital improvement services will be financed through a special tax pursuant to §25215.2 of the Government Code
- Mame of Zone. The name of the zone shall be Western Slope Cemetery Zone of Benefit within County 85 B 1 of 2 Service Area No. 9.
