# MEMORANDUM OF UNDERSTANDING Between The EL DORADO COUNTY SHERIFF'S OFFICE And The EL DORADO COUNTY DEPARTMENT OF TRANSPORTATION And The CALIFORNIA DEPARTMENT OF PARKS AND RECREATION OFF-HIGHWAY MOTOR VEHICLE RECREATION DIVISION And The USDA, FOREST SERVICE ELDORADO NATIONAL FOREST

This MEMORANDUM OF UNDERSTANDING (MOU) is hereby made and entered into by and between the El Dorado County Sheriff's Office, hereinafter referred to as "EDSO"; the El Dorado County Department of Transportation, hereinafter referred to as "DOT", and the California Department of Parks and Recreation Off-Highway Motor Vehicle Recreation Division, hereinafter referred to as "OHMVR Division" and the USDA, Forest Service, Eldorado National Forest, hereinafter referred to as the "U.S. Forest Service."

Title: Rubicon Trail Management Agreement

I. PURPOSE: The purpose of this MOU is to document the cooperation between the parties for the improvement, management and operation of the Rubicon Trail for recreational use, protect and enhance the natural and cultural resources, to provide for public safety and to ensure the Rubicon Trail and surrounding public lands remain available for long-term ecologically sustainable, recreational use. The Rubicon Trail is a 22 mile trail that routes through El Dorado County and the Eldorado National Forest.

#### **II. STATEMENT OF MUTUAL BENEFIT AND INTERESTS:**

It is mutually beneficial to provide for the comprehensive management of the Rubicon Trail to ensure the protection of natural and cultural resources and for the safety of the public.

It is mutually beneficial to provide interpretive, educational and outreach programs to the recreating public on the Rubicon Trail.

It is mutually beneficial to promote ecologically balanced recreation management on the Rubicon Trail and surrounding public lands.

The EDSO is responsible for public safety and the enforcement of state law and county ordinances

The DOT is responsible for trail maintenance.

The OHMVR Division is responsible for technical assistance regarding trail maintenance and public education.

The U.S. Forest Service provides opportunities for the public to recreate on National Forest Lands and assist with compliance of laws and regulations.

In consideration of the above premises, the parties agree as follows:

### III. ALL PARTIES SHALL:

- A. Coordinate the planning and management regarding the Rubicon Trail.
- B. Provide for the enforcement of the California Vehicle Code, other Federal and State laws and County Ordinances regulating the use or equipment of OHVs on the Rubicon Trail and surrounding public lands under the parties' jurisdiction.
- C. Coordinate efforts to provide interpretive, educational, and outreach programs to the recreating public on the Rubicon Trail.
- D. Parties may enter into separate agreements to enact Annual Operating Plans (AOPs) to better coordinate personnel and resources to accomplish the goals of Section B.

## IV. THE EDSO SHALL:

- A. Enforce Division 16.5 (commencing with Section 38000) of the California Vehicle Code on the portion of the Rubicon Trail in El Dorado County, as well as all other State laws and County Ordinances.
- B. Be the lead agency and provide search and rescue services for the portion of the Rubicon Trail in El Dorado County in accordance with the previous agreement numbered 10-MU-11050374-013
- C. Send a representative(s) to Rubicon Oversight Committee (ROC) meetings in Placerville, California. At each ROC meeting, the EDSO representative(s) will provide a report relative to OHV enforcement activities on the Rubicon Trail.

# V. THE OHMVR DIVISION SHALL:

- A. Operate an OHV local assistance program to provide competitive-based financial assistance to applicants, including the USFS and the DOT. The local assistance program may provide supplemental financial assistance, as available and under separate agreement, to facilitate the maintenance, restoration, conservation and operation of the Rubicon Trail.
- B. Operate an OHV local assistance program to provide need-based financial assistance, as available and under separate agreement, to the USFS and EDSO for enforcement of Division 16.5 of the California Vehicle Code.
- C. Provide technical assistance to the DOT for compliance with the 2008 Soil Conservation Standard.
- D. Provide technical assistance to the EDSO on OHV related law enforcement activities on the Rubicon Trail, including training in and the enforcement of provisions of Title 14, CA Code of Regulations.
- E. Send a representative(s) to Rubicon Oversight Committee (ROC) meetings in Placerville, California. At each ROC meeting, the OHMVR Division representative(s) will provide a report on the status of the OHV local assistance program and OHMVR Division enforcement activities on the Rubicon Trail.

# VI. THE DOT SHALL:

- A. Make Rubicon Trail access maps publicly available.
- B. Provide maintenance activities for the portion of the Rubicon Trail in El Dorado County to ensure compliance with the 2008 Soil Conservation Standard.
- C. Facilitate the Rubicon Oversight Committee (ROC) meetings in Placerville, California. At each ROC meeting, the DOT representative(s) will provide a report to the ROC relative to maintenance on the Rubicon Trail.

## VII. THE U.S. FOREST SERVICE SHALL:

- A. Enforce Division 16.5 (commencing with Section 38000) of the California Vehicle Code and applicable provisions of Title 36 CFRs, including any Special Orders, on the Rubicon Trail and surrounding public lands.
- B. Provide guidance and oversight to ensure compliance with NEPA requirements for any projects that may require NEPA analysis and documentation.

D. Send a representative(s) to Rubicon Oversight Committee (ROC) meetings in Placerville, California. At each ROC meeting, the USFS representative(s) will provide a report relative to the state of the Rubicon Trail and surrounding public lands.

To Cooperators, at Cooperators' address shown in the MOU or such other address designated within the MOU.

Notices are effective when delivered in accordance with this provision, or on the effective date of the notice, whichever is later.

- D. <u>PARTICIPATION IN SIMILAR ACTIVITIES</u>. This MOU in no way restricts the U.S. Forest Service or Cooperators from participating in similar activities with other public or private agencies, organizations, and individuals.
- E. <u>ENDORSEMENT</u>. Any of Cooperators' contributions made under this MOU do not by direct reference or implications convey U.S. Forest Service endorsement of products or activities.
- F. <u>NONBINDING AGREEMENT</u>. This MOU creates no right, benefit, or trust responsibility, substantive or procedural, enforceable at law or equity. The parties shall manage their respective resources and activities in a separate, coordinated and mutually beneficial manner to meet the purpose(s) of this MOU. Nothing in this MOU authorizes any of the parties to obligate or transfer anything of value.

Specific, prospective projects or activities that involve the transfer of funds, services, property, and/or anything of value to a party requires the execution of separate instruments and are contingent upon numerous factors, including, as applicable, but not limited to: agency availability of appropriated funds and other resources; cooperator availability of funds and other resources; agency and cooperator administrative and legal requirements (including agency authorization by statute); etc. This MOU neither provides, nor meets these criteria. If the parties elect to enter into an obligation instrument that involves the transfer of funds, services, property, and/or anything of value to a party, then the applicable criteria must be met. Additionally, under a prospective instrument, each party operates under its own laws, regulations, and/or policies, and any Forest Service obligation is subject to the availability of appropriated funds and other resources. The negotiation, execution, and administration of these prospective instruments must comply with all applicable law


