WHEREAS, the Board of Supervisors has reviewed and held public hearings on the recommended amendments to the Economic Development Element; and

WHEREAS, the Board of Supervisors finds that the proposed amendments to the General Plan are consistent with all elements of the General Plan not otherwise amended.

NOW, THEREFORE, BE IT RESOLVED that the County of El Dorado Board of Supervisors hereby approves and accepts the following amendments to the General Plan, and approves and adopts the following amendments to the General Plan based on the findings and reasons set forth in the staff report and except as may be noted herein:

Policy 10.1.6.4:
