Honorable Board Members,

We would like our comments to be included in the informational packets relating to Agenda Item 45 which considers the reapportionment of the Transient Occupancy Tax generated in the County. I am very much in favor of eliminating the current requirement which earmarks 51% of the tax to go to tourism. I believe that Tahoe does not need further promotion; it is a redundancy to advertise what is known by history and word of mouth. We have many other agencies in Tahoe whose goal is to increase tourist revenue by advertising; we don't need the TOT which is generated mostly in the Basin to be used for advertisement.

Instead, I would like to see some of that money applied to mitigate the environmental degradation, perhaps due to this over promotion, that takes place now almost every season in our Tahoe neighborhoods caused by millions of tourists in their cars. Specifically, the potholes in our roads, the noise and clutter caused by vacation home renters in our neighborhoods which have effectively been turned into hotel districts, the trash on our beaches, overcrowding so that locals can't enjoy their communities. Ideally, tourist traffic should be kept out of our residential neighborhoods; it should be controlled by use of signage, specifically "no turn onto 50" signage as proposed by Tony Risso and Jeffery Spencer of our Meyers community; in addition that signage should be enforced; hence these would be appropriate uses for all of the 51% of the tax. We are tired of our visitors who, caught in all night traffic jams on our neighborhood streets because of apps who have directed them to these "shortcuts" find no place to relieve themselves, and find the need to defecate in our driveways and in the alleyways behind our businesses, especially those in Meyers. This constitutes a health hazard; which should be prevented with the use of TOT monies to establish convenient highway accessed restrooms outside of our neighborhoods. Monies could also be used for the locals in Tahoe; and for the benefit of those who have to suffer in their residential neighborhoods from the degradation caused by tourists who are not part of our community; specifically monies might be used to establish greenways and parks, a softball field for Tahoe Paradise Park comes to mind.

In conclusion, TOT monies should be earmarked not for tourism, but for the alleviation of the problems which over-tourism has created in our beautiful Tahoe basin. Please keep these monies where they are generated and use them to mitigate the many problems which too much advertising has now created here or use them to further beautify our Tahoe community.
