#### FIRST AMENDMENT TO FUNDING AGREEMENT No. #2914

**THIS FIRST AMENDMENT** to Agreement #2914 made and entered into by and between the **County of El Dorado Air Quality Management District**, a county air quality management district formed pursuant to California Health and Safety Code section 40100, et seq. (hereinafter referred to as "AQMD"), and **El Dorado County Department of Transportation** (hereinafter referred to as "Grantee");

#### WITNESSETH:

WHEREAS, Grantee has proposed a Project that meets the eligibility criteria of AQMD and that has been approved by AQMD and the Governing Board of AQMD for funding; and

**WHEREAS**, the parties hereto desire to amend the Agreement to extend the term of the agreement;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, AQMD and Contractor mutually agree that Agreement #2914 shall be amended a first time, as follows:

I. Article 2, "Period of Performance/Timetable", Section b) of the Agreement is amended in its entirety to read as follows:

### 2) PERIOD OF PERFORMANCE/TIMETABLE

b) GRANTEE shall submit quarterly performance reports and a comprehensive final report. The quarterly reports shall detail the work performed during the previous quarter; work planned for next quarter; problems identified, solved, and/or unresolved; and the percentage of each task completed. Quarterly reports shall be due 30 days after the end of the previous calendar quarter. GRANTEE shall provide AQMD with a comprehensive final written report by September 1, 2020. Said final report shall be complete and shall document the work performed under this Agreement.

## II. Article 3, "Term" of the Agreement is amended in its entirety to read as follows:

### **3)** <u>**TERM**</u>

The term of this Agreement shall be effective upon final execution by the parties and as amended, shall cover the period of June 26, 2018 through September 1, 2020 unless terminated earlier in accordance with Article 7, Termination. All eligible project costs, except for final report preparation costs, must be incurred prior to June 30, 2020.
