### FIRST AMENDMENT TO AGREEMENT FOR SERVICES #3683

### RECITALS

**WHEREAS**, Contractor has been engaged by County to provide commercial cardlock fueling services for all El Dorado County owned vehicles pursuant to Agreement for Services #3683, dated February 6, 2019, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$200,000, amending ARTICLE III, Compensation for Services;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement on the following terms and conditions:

I. ARTICLE III, Compensation for Services, paragraph six is amended to read as follows:

Total amount of this Agreement shall not exceed one million two hundred thousand dollars (\$1,200,000) for the one (1) year period, inclusive of authorized vending machine purchases in accordance with this Agreement.

Except as herein amended, all other parts and sections of Agreement for Services #3683 shall remain unchanged and in full force and effect.
