Hello Supervisors,

After the disappointing support for District 4 Supervisors request to reject the higher density of the Vineyards Project, I wanted to get a letter out quickly. In short, the history of these projects is VERY long (12 years) as well as the other Malcolm Dixon Projects. You need to know the history to vote appropriately. The locals here are very upset about this.

All of you were never present over the years to see and experience what the community has sacrificed so I don't blame you as there is now way for you to know. I was not given enough time to bring you up to speed which you are entitled to know. I'm sure when you are all up to speed and know the history, you will support District 4.

I do need to get this off my chest.....

On October 26, 2017 at the Vineyards project scoping meeting, I told the Omni staff (with other witnesses present) about the agreement to go no less than 5 acres with Diamante and our frustration with them to come back for more. To sidestep that knowledge at the BOS meeting and say they never knew about it is a BOLD and MAJOR LIE!!! I tried desperately to comment on that. A call to anyone on the participation list of the scoping meeting will demonstrate the objection of this project.

I will be sending you old newspaper articles about these projects, some history and other comments about this area. It will then make sense. I encourage you to read them. I know you are busy here at the holidays but these are homes and lives. Please support District 4 Supervisor.
