Our concern about the project, including density housing, maintaining the ecosystem, and traffic congestion have been have been addressed in numerous forums. Our expectation is that you are representing our collective public interests and concerns.

I and many citizens will use our vote to obtain a representative that actually represents constituents as opposed to developers with deep pockets. While I can't make all of the public forums, that does not mean I am ambivalent about our community. My expectation is that you take my input seriously. 

Dear Board of Supervisors

I have only lived here since 1997 but I call EDH home now. I remember playing golf at the course along EDH Blvd before and after work some days. It was really impactful to my life. I was sad to see the course go. But what will be more upsetting is to see our open space diminished further. I look at Blackstone with no green space on the roads and no open space and it just looks like a virus is taking over the earth there.

We need to draw the line at the county border to develop responsibly with in the framework consistent with our communities values. I do NOT want our community to end up looking like an extension of Folsom. If I wanted that I would have bought in Folsom in the first place.

I like saying I'm from a rural county in the foothills of the Sierra Nevada mountains.

I do not want to see our five acre parcels near Malcolm Dixon chopped up to suit developers. I do Not want to see our open space along the EDH corridor north of highway 50 on the east side of the road developed. I love the bowman and the rocks. It's part of our community. Didn't a nice fence get built there as part of someone's Eagle Scout project?

I'm not particularly skewed towards "slow" growth. But I am in favor of rural responsible growth. Put in marble valley finally. But make sure the boulevards are wide enough for trees in the middle. Make sure there are big parks and open spaces. If you want high density housing put it around a commercial area to make a nice walking zone between houses and shopping. Make sure that the vast majority of lots are at a minimum .5 acres with skewing the average to 1 acre and have luxury 5 acre or more lots. Put in an appropriate interchange.

Those are my thoughts. I wish I could be there on the 14th but I will likely be watching my children. So I hope my email stands in place of being there.
