Subject: Notice of Non-Performance & Substitution Request

Mr. Willis,

As you are aware per our previous verbal and e-mail correspondence, Steelhead Constructors, Inc. (SCI) has formally requested subcontractor substitution pursuant to our Subcontract Agreement (No. 154-10), and Public Contract Code §4107, due to non-performance.

Willis Rebar, Inc. (WRI) has failed to comply with and perform under the Subcontract Agreement, including but not limited to Section D. Time & Schedule, and Section I. Compliance with Laws and Safety Requirements.

SCI has provided timely notice to WRI as to when reinforcing steel materials and labor for installation of materials would be needed, and WRI's inability to perform has delayed and disrupted the progress of the work.

Certified Payroll for the months of October & November, 2019 have not been submitted despite numerous requests. This is in violation of the Subcontract Agreement and California Department of Industrial Regulations Labor Code.

To date, SCI has received two (2) progress payments from the County of Eldorado (Owner) that included payment for portions of WRI's contract pay items. Total value of WRI's work performed as paid by the County of Eldorado under the Subcontract Agreement is \$78,353.44, less 5% retention. Payment for WRI's work performed through July 31, 2019, has been paid in full totaling \$33,276.00, less 5% retention. The forthcoming payment balance is \$45,077.44, less retention. A copy of the County's Current Pay Estimate for work performed through October 21, 2019, was provided to you on November 1, 2019.



As requested by WRI, all payments have been processed through a joint check agreement with WRI's rebar supplier, Farwest Steel. Total amount(s) of WRI's unpaid progress payment(s) to Farwest steel is \$36,488.97, through October, 2019.

SCI has processed payment to WRI for all work performed by WRI, as paid by the County of Eldorado, except for work performed through October 21, 2019 due to missing Certified Payrolls. Withholding of progress payments due to no receipt of certified payroll is in accordance with California Labor Code and our Subcontract Agreement.

Please provide all outstanding Certified Payrolls so that October's progress payment can be made to WRI & Farwest Steel, and timely processing of November's progress payment can be made to you upon receipt from the Owner.

Mr. Kockrow,

As you stated in your letter, we are aware Steelhead Constructors Inc (SCI) has formally requested to substitute us on the Bassi Rd. project.

Willis Rebar, Inc (WRI) informed SCI we would not be able to perform last week as scheduled *due to a lack of funds*. This decision was made after attempts over many weeks via email, phone conversations, and texts to explain WRI would not be able to financially support more labor without further compensation for work completed.

WRI has been working on two (2) projects for Steelhead with very little compensation for approximately five (5) months. We have not received any payment for our work on Hat Creek. Out of the \$33,276 paid on this project, approximately \$11,000 was paid to WRI. The remaining balance was paid to our supplier. The amount paid to WRI does not cover more than a week's worth of labor on one (1) project. Our inability to meet our schedule at Bassi Rd. this week is in direct correlation to SCI's decision to not pay more on our shared projects.

I understand SCI has only received two progress payments on this project. I also understand you sent payments to our suppliers. As we have reiterated many times: this does not assist in covering wages,

benefits, and infrastructure costs that have already been incurred. We are prepared to continue work on these projects as soon as we are compensated for work completed.

My biggest concern reviewing this letter is that the total value of WRI's work on this project – per our signed agreement – is \$149,637.94 not \$78,353.44. The amount you have cited as the total contract amount would barely cover costs to our supplier on this project. Please see the attached signed contract. We fully expect to receive payment in the amount agreed upon in the signed contract if we continue to work on this project. If you have us removed from this project, we will submit an invoice for labor costs that have not been paid at this time.

As for the delay in submitted CPRs: The first request for October CPRs we received was on November 21 from Melanie Olsen. At this time, we have not received a request for November CPRs. I will ensure all CPRs are submitted by Friday. I was not informed until last week that payment on this project was being held due to delayed CPRs.

Troy, I understand that you are going through the process that you believe will be best for your employer.

We cannot meet our schedule because you continue to hold our payments.

We have been working on 2 projects for Steelhead with very little compensation for approximately 5 months. We have not received a dime on Hat Creek and approximately \$11k on Bassi Rd. This doesn't not cover more than a week's worth of work.

Previously, your argument was that our supplier's material delay impacted the project and you were concerned there would be penalties that you must pay. As that long no longer seems to be the case, your new argument is you cannot pay us because you have not been paid.

I understand your position; however we cannot continue to work for free. Your payment to Farwest does not pay wages or benefits for our employees.

We are not in a position to pay our employees for more work if we do not receive compensation from you. Your company needed a Disadvantaged Business Enterprise (DBE) in these projects. We are a DBE. This means we do not have the infrastructure to continue to work on the promise of pay 6 months after we've started a project.
