AGREEMENT FOR SERVICES #3523

AMENDMENT I

This Amendment I to that Agreement for Services #3523, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Stanford Youth Solutions, a California non-profit public benefit corporation, duly qualified to conduct business in the State of California, whose principal place of business is 8912 Volunteer Lane, Sacramento, CA 95826, (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide outpatient Specialty Mental Health Services (SMHS) for County-authorized Clients, in accordance with Agreement for Services #3523, dated December 4, 2018, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to amend Article IV, "Maximum Obligation."

NOW THEREFORE, the parties do hereby agree that Agreement for Services #3523 shall be amended a first time as follows:

ARTICLE IV shall be amended in its entirety to read as follows, and shall become effective upon execution of this Amendment 1:

ARTICLE IV

Maximum Obligation: The maximum contractual obligation under this Agreement shall not exceed the combined total of the annual not-to-exceed amounts as set forth herein.
