To Whom It May Concern

I wish to express my wholehearted support of the Joint Policy On Homelessness and the use of the State owned Armory, for a Navigation Center and transitional housing to address our homelessness issue. Nearly every county in California provides transitional housing for the homeless. Sadly, El Dorado County does not. We have recently heard that even the Nomadic Winter Shelter previously provided by a few volunteer churches on some nights during winter weather in past years will probably not exist next winter. The result will be more homeless people suffering, and some will die. We treat our homeless pets better. For all of our sakes, not just the homeless, we need to address the homelessness issue now, especially as we go through and then try to come out of the Covid 19 Pandemic.

Providing a Navigation Center with transitional housing will benefit not only the homeless, but all of us. First, most of our homeless ARE "us" They are "locals", not transients from somewhere else. The official Point In Time count of homeless people shows that most of our homeless are local residents, not transients. Many of them grew up here. I have volunteered at the Nomadic Shelter and I personally know this to be true. Additionally, the number of homeless people in our County is likely to increase soon due to the economic effects of the Covid 19 Pandemic. These are people who have lost their jobs due to no fault of their own. The number of homeless people camping in the woods and nearby neighborhoods will increase. The homeless need a Navigation Center and transitional housing to get the help they need to get back on their feet.

The homelessness problem is not going to go away on its own. Not providing shelter and services will not reduce the number of homeless people in our community. Conversely, providing temporary shelter and services will not exacerbate the problem; it will improve it. Right now, the homeless have no running water, toilets, showers, or links to the services they need to get out of homelessness. Providing services and transitional housing will lessen the litter and sanitation problems we see, and it will reduce the number of people having unsafe campfires that threaten all of us during fire season. Progressively, it will reduce the number of homeless people in El Dorado County.

It is no longer a question of whether to provide services to the homeless, services that enable them to obtain housing and re-enter the workforce, but a question of where those services should be provided within our County. The Armory is being offered by the State to the County to address the homelessness problem. This is a tremendous opportunity to begin to address not only the humanitarian issues posed by homelessness, but also the well-being of our whole community, including the residents of the City of Placerville, Our entire community will benefit from addressing the homelessness problem. The scare tactics of some who refer to the Armory as part of the Fairgrounds and exaggerate its proximity to children are just that, scare tactics. The State owned Armory is not part of the Fairgrounds. It is not in view of the New Morning Shelter. Use of the Armory does not threaten the safety of our children. I have no doubt that security, supervision, services linking homeless individuals to needed social services, and the provision of trash and sanitation services will be part of this project at the Armory. Safety and cleanliness on the streets of Placerville and in residential neighborhoods will improve as a result of this proposal. The fire danger from camp fires will be reduced. I trust that our hard working and conscientious County Board of Supervisors and City officials, people who care about ALL of us, will make this project a win/win for all people of this community.

I oppose El Dorado County signing with the City of Placerville the proposed "Joint Policy Statement on Homelessness".

This "Statement" includes 6 action items. Action one is to "Authorize staff of both jurisdictions to immediately evaluate the feasibility of the ...Armory as a Transitional Housing Navigation Center in order [to] **temporarily house** and provide resources to the homeless."

The "Statement" also states that "**Current efforts** [regarding the Homeless problem] on behalf of El Dorado County Health and Human Services Agency, the Sheriff's Department and El Dorado Opportunity Knocks **are seeing success**." So why now the rush for adopting this "Statement" which includes 6 ACTIONS?! The only reason mentioned as to the rush is, "we continue to see problems that warrant additional and immediate action to remedy." What are the problems? Without knowing the problems, how can anyone determine the need for this "immediate action"?

This item could not be brought forth at a worse time. The public has been told that this is the week they should be most concerned with the COVID-19 virus. We are to shelter in place until at least the end of April and now is when the County has decided to take emergency actions to place a transient population into the center of the City of Placerville?

Currently during this COVID-19 epidemic we have been told that the best medical practices is to allow the transient population to shelter in place and bring the services to them... which we are told that County is implementing and is successful.

Seems that there have been many working on this item without much public knowledge or input and there seems to be much missing from the discussion in order for the decision makers to come up with a good solution. The actual problems have not been identified that justifies the actions being taken. demographics? Simply setting up a "Transitional Housing Navigation Center" does not seem to be any different than what the County can currently provide except for actual housing.

There also needs to be consideration to the impact this County project will have to Placerville's businesses and residents.

If this is merely to have a center in order to be able to legally move the homeless out of our public places then the county needs to look for a location outside of the City of Placerville on County property that can be managed in order to not make the existing problem worse and will also serve those that truly want the service. A few parcels that come into mind is the 10 acres that the County owns at the El Dorado Y, or I think there is still 4 acres owned by the County adjacent to the County Safety Facility. The problem with this item is that only one location has been identified and if this project was taken out of the City there would be no Statement of Actions needed. Instead we might be looking at an MOU from the City for services provided by the County.

During this crisis just think if the County was working on getting a local Mill back in the county in order to assist those residents, homeless or not, that have suffered since the last of our mills closed down. Applying to the Feds for policies to be corrected in order to facilitate that type of industry in our forest could go a long way to actually solve many problems our county has been facing, including homelessness, since the closure of our mills.

Please do not approve this Statement agreement. This item should be brought back for discussion with a lot more data made available for the Board of Supervisors to consider, in order for them to make decisions that will benefit the health and welfare of our entire county as a whole.

Currently during this COVID-19 epidemic we have been told that the best medical practices is to allow the transient population to shelter in place and bring the services to them... which we are told that County is implementing and is successful.

Seems that there have been many working on this item without much public knowledge or input and there seems to be much missing from the discussion in order for the decision makers to come up with a good solution. The actual problems have not been identified that justifies the actions being taken. This agreement appears to be following the model of Hangtown Haven which actually brought more homeless to our communities and has created an unmanageable situation. If neither the City or the County has been able to mitigate the situation created by the Haven, how is recreating that program going to make things better for those that are in need along with the already impacted residents and businesses? Hangtown Haven was closed by the City of Placerville on 11/15/2013. Per the Sacbee:

"PLACERVILLE, Calif. — A self-governing tent city of homeless residents in Placerville is closing after just 16 months following complaints the camp increased litter and property crime... the camp known as Hangtown Haven will be shut down Friday when its city permit expires. The social experiment was heralded by local officials and homeless activists in dealing with a problem of transients taking over local parks or setting fires in the woods...But police said Placerville became a destination point for homeless people who came from as far as New York. As a result, thefts shot up by 60 percent."

I've listened to Supervisor Hidahl say that this item is "just" to be able to have an open dialog to the homeless situation within the county, yet the Statement being presented to the Board of Supervisors has 6 actions items! His explanation of the item is actually contrary to what is actually in the proposal. We do agree that many advocates of the homelessness along with government officials have been eyeing the Armory to house the homeless ever since Newsom opened up that any state property could be used for housing the homeless. We should put that topic to rest and state that this site is not an appropriate location to mitigate homelessness. Next there should be a discussion as to which population the County is looking to serve. Such as the working homeless, the transient homeless, the mentally ill homeless, the veteran homeless, the homeless youth? Each of these demographics would require a different type of service. Do we already have services that is working for any of these demographics that are being implemented? Perhaps through our Health and Human Services and Mental Health Departments.

If one of these demographics are not being served then what would be the best action that would actually eliminate homelessness for that

demographics? Simply setting up a "Transitional Housing Navigation Center" does not seem to be any different than what the County can currently provide except for actual housing.

The staff has been verbally harassed, threatened with physical harm and in one instance physically attacked. Bringing more of the homeless/transient community, which inherently suffers from mental disease/drug & alcohol addiction, would bring more of this to our fairgrounds.

The Armory is also directly across the street from New Morning's Children's Shelter, and only 350 ft from Joe's Skate Park, a local youth hang out. The Fairgrounds is also the venue for the many large youth activities, including the All County Cross Country Meet's annual race which is attended by almost 1,000 3rd Grade Kids and Farm Day, with 800 4th Graders. Transient housing being located at the Armory endangers our youth.

The homeless/transient community does not blend well with the events that utilize these facilities. Events such as; Kids Expo, the Annual Fair, Fire Camps, fundraisers for local nonprofits, flu clinics, just to name a few. Many events will likely move to venues outside of the county or cancel. This would be a significant loss of revenue to our local economy.

1. The majority of the homeless neighbors in EDC are from EDC. They are not transient people, according to the most recent Point in Time Count.

2. Our County is in desperate need of a Navigation Center with Transitional Housing. Locations all over the state have done this. A recent visit to one in Marysville found it clean and well supervised. According to one of the Yuba County Board of Supervisors, the neighbors in the area reported no problems.

3. The Armory is not on Fairground Property and is the property of the State. It is being made available by the State of California only for housing and is not available for other purposes. If the Armory was chosen, the location is away from the Fairgrounds itself, it is fenced off and not even within view of New Morning or the Skate Park.

4. Providing services for the homeless has been found to protect the community from problems and makes the community a safer place.
