Subject: Medicinal Marijuana Outdoor Grows -- Agenda Item #27, May 5, 2020

We want to express our STRONG SUPPORT for the proposed amendment to limit the number of marijuana plants that may be grown outdoors for personal medicinal purposes to 6 plants, as recommended by our County staff, the County Sheriff and the County District Attorney. Changes must be made to improve clarity and to enable enforcement of the rules against illegal marijuana grows, especially outdoors. Please give final approval to these EMERGENCY amendments!
