The Health and Human Services Agency (HHSA), Community Services Division (CSD), Older Adult Day Services Program, is requesting a budget transfer to move General Fund savings from the Area Agency on Aging (AAA) to Older Adult Day Services. The closure of the Senior Day Care facility during the Covid 19 emergency has caused a loss of client fee revenues and an increase in the County General Fund request.

AAA Senior Nutrition Program, is requesting a budget transfer to increase State Revenues, Temporary Employees, and Food and Food Products. The increase to the AAA Sr. Nutrition Program is related to a one-time State funding allocation augmentation of \$138,894 and a COVID emergency funding allocation of \$158,136 from the Families First Coronavirus Response Act (FFCRA).

There is no net impact to county general fund.
