Dear Supervisor Parlan and Members of the El Dorado County Board of Supervisors:

I live in Cool, attend Cool Community Church, and work for Placer County. In my duties at Placer County, I have some insight into the challenges you face in protecting your constituents in the face of limited data, changing state orders, and polar opinions. I honor your efforts.

My purpose is to encourage your Board to uphold two important principals as we move forward through the COVID-19 response:

1. Define generally applicable distancing and hygiene protocols to protect your constituents.
2. Resist arbitrary and discriminatory application of those protocols that restrict constitutional liberty

As a political subdivision of the State of California, you have a high responsibility to adhere to state orders. You have a higher responsibility to uphold the constitutional freedoms that you took an oath to defend.

There is no such thing as unbiased decision making. The worldview of the decision maker necessarily influences how scientific data is interpreted and applied. In the early uncertainty of the COVID crisis, it may have been understandable that activities outside the home were limited to the support of basic food and shelter. Those activities were singled out as "essential". Food and shelter are not, however, the only essentials of life, and as time goes on, other essentials become more urgent. Spiritual, relational, and economic wellbeing are manifestly essential to human thriving. It is now clear that state decision makers are making arbitrary and discriminatory application of COVID restrictions with essential activities being defined by the personal priorities of the Governor and not the application of scientific data. Here are a few examples:

- Essential: Household groups distanced between other groups throwing a ball
- Non-essential: Household groups distanced between other groups singing hymns
  
- Essential: Individuals spaced 6 feet apart with gloves and masks buying beer and chips
- Non-essential: Individuals spaced 6 feet apart with gloves and masks listening to a sermon
  
- Essential: curbside delivery of fast food
- Non-essential: curbside delivery of a framed portrait for a birthday present
