## THIRD AMENDMENT TO AGREEMENT FOR SERVICES \#280-01810

THIS THIRD AMENDMENT to that Agreement for Services \#280-O1810 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and California Compaction Equipment, Inc., a corporation duly qualified to conduct business in the State of California, whose principal place of business is 2546 Riego Road, Pleasant Grove, California 95668, and whose mailing address is Post Office Box 1517, Woodland, California 95776 (hereinafter referred to as "Lessor");

## RECITALS

WHEREAS, Lessor has been engaged by County to provide various types of equipment rentals for the Department of Transportation, pursuant to Agreement for Services \#280O1810, dated November 30, 2017, First Amendment to Agreement for Services \#280O1810, dated October 9, 2018, and Second Amendment to Agreement for Services \#280-O1810, dated February 25, 2020, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-toexceed compensation amount of the Agreement by $\$ 50,000$, amending ARTICLE III, Compensation;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Lessor mutually agree to amend the terms of the Agreement in this Third Amendment to Agreement on the following terms and conditions:
I. ARTICLE III, Compensation, the fourth paragraph of the Agreement is amended in its entirety to read as follows:

The total amount of this Agreement, as amended, shall not exceed $\$ 179,000$, inclusive of all costs, taxes, and expenses.

Except as herein amended, all other parts and sections of Agreement for Services \#280-O1810, as amended, shall remain unchanged and in full force and effect.
