Good morning Audra and Kerri,

Cal OES is extending and augmenting your 2019 VV Program Subaward to move the end of your performance period to December 31, 2020. This will change the future VV performance periods from July 1 – June 30 to January 1 - December 31 annually. You will receive an increase in both 18VAWA and 19VAWA funds equal to 50% of your original award. This will enable you to provide the same level of client service for the entire 18-month performance period.

The **18VAWA funds** must be spent before 19VAWA funds once your grant is amended. This allows Cal OES to reallocate 18VAWA funds and ensure funds are utilized for California victims and not returned to the federal government. **We request you submit the Amendment and Modification forms along with a new budget on or before April 17, 2020.**

All forms can be scanned and emailed, original forms are not necessary. You can also scan and email forms to signers if your office is teleworking. Please feel free to email me with any questions and let me know if I can assist with your new budget.

**Your VV Grant Subaward will be augmented with the following increases:**

- **2018 VAWA funds of \$74,391**
- **2018 VAWA match \$24,797**
- **2019 VAWA funds by \$26,881**
- **2019 VAWA match by \$8,960**
