Early Learning in the Neighborhood GRANT AGREEMENT AND CERTIFICATION OF COMPLIANCE

This is the Early Learning in the Neighborhood Grant Agreement (award number SVBT-043) and Certification of Compliance between the California State Library and El Dorado County Library, henceforth referred to as Grantee.

The Grantee designated above hereby certifies to the California State Library that the grant of \$132,643 will be used solely to carry out the program set forth in its Early Learning in the Neighborhood application as approved, and/or as amended and approved by the California State Librarian.

TERMS AND CONDITIONS

The Grantee and its named or designated fiscal agent (if applicable) hereby assures the California State Library that:

- It is mutually understood between the parties that this grant award may have been made before the availability of appropriated funds was ascertained. This was done for the mutual benefit of both parties in order to avoid program and fiscal delays which would occur if the grant award were executed after that determination was made.
- 2. This grant award is valid and enforceable only if sufficient funds are made available to the California State Library in the Enactment Year 2019 State Budget for the purposes of this program. In addition, this grant award is subject to any additional restrictions, limitation, or conditions enacted by the Legislature and approved by the Governor, which may affect the provisions, terms or funding of this grant award in any manner.
- 3. It is mutually agreed that if sufficient funds are not appropriated for the program, this grant award shall be amended to reflect any reduction in funds.
- 4. It is mutually agreed that the grant application and the timeline included therein are part of the grant agreement.
- The complete Early Learning in the Neighborhood GRANT AGREEMENT and CERTIFICATION OF COMPLIANCE shall constitute the grant agreement for the project.

- 6. The Grantee shall report to the State Librarian in such form and containing such information as may be required to enable the California State Library to administer the grant. The Grantee shall keep records and afford access to records concerning the grant as the California State Librarian finds necessary to assure the correctness and verification of grant reports.
- 7. The expenditure under this program shall not be used to supplant Grantee efforts in other programs.

This agreement is subject to the provisions of the Budget Act of 2019, Chapter 23 of the Statutes of 2019. Performance of the provisions of this agreement is subject to the conditions and availability of funds as awarded by the State Librarian under the Act.

 The terms of this agreement shall be upon execution until the end of the grant period, but shall be subject to termination by the State Librarian upon notice to the grantee at least thirty (30) days prior to the effective date of termination. The State Librarian may extend the final deadline for good cause. Request for extension beyond the final deadline of the end of the grant period must be received at least 30 days prior in writing to that deadline at the State Librarian's office.

In the event this agreement is terminated, the Grantee shall deliver to the State Librarian copies of all reports and/or materials prepared up to the date of termination, and the State Librarian shall determine, and pay the grantee for necessary and appropriate expenditures and obligations to the date of termination which have not been covered by prior installments previously paid to the Grantee. If funding has been advanced to the Grantee, any unobligated balances, as determined by the State Librarian, shall be returned to the State Library within 60 days of the notice of termination.

- 2. The State Librarian may at any time during the term of this agreement review, audit, and inspect the project for compliance with this agreement.
- The California State Library shall be acknowledged in all promotional materials and publications related to the Early Learning in the Neighborhood project.
- 4. Original material produced with these grant funds may be copyrighted by the Grantee or its assignees. However, the California State Library reserves a royalty-free, nonexclusive, and irrevocable license to reproduce, publish, or otherwise use, and to authorize others to use, for public library and State governmental purposes:
 - a. The copyright in any work developed under this grant, sub-grant, or contract under this grant or sub-grant; and

b. Any rights of copyright to which a Grantee, sub-grantee, or a contractor purchases ownership with grant support.

The foregoing provision specifically authorizes the California State Library to mount copyrighted material produced or purchased with grant funds on a California State Library website for public access and viewing.

- 5. Nothing contained in this Agreement or otherwise shall create any contractual relation between the State and any subcontractors, and no subcontract shall relieve the Grantee of his/her responsibilities and obligations hereunder. The Grantee agrees to be as fully responsible to the State for the acts and omissions of its subcontractors, volunteers, student interns and of persons either directly or indirectly employed by any of them as it is for the acts and omissions of persons directly employed by the Grantee. The Grantee's obligation to pay its subcontractors is an independent obligation from the State's obligation to make payments to the Grantee. As a result, the State shall have no obligation to pay or to enforce the payment of any monies to any subcontractor.
- 6. Grantee has the right to perform services for others during the term of this agreement.
 - a. Grantee has the right to perform the services required by this agreement at any location or at any time during the grant period, following the agreed-upon timeline.
 - b. Grantee shall furnish all equipment and materials used to provide the services required by this Agreement.
 - c. Grantee, Grantee's employees or contract personnel shall perform all services required by this Agreement; and beyond general monitoring and administration of the grant contract, the State Library shall not hire, supervise or pay any personnel to assist Grantee.
 - d. The State Library shall not provide any training to Grantee, Grantee's employees or contract personnel with the skills necessary to perform the services required by this Agreement.
 - The State Library shall not require the Grantee, Grantee's employees or contract personnel to devote full time to performing the services required by this Agreement.
- 7. Indemnification: Grantee agrees to indemnify, defend and save harmless the State of California, its agents, and employees from any and all claims and losses accruing or resulting to any and all contractors, subcontractors, suppliers, laborers and any other person, firm or corporation furnishing or supplying work services, materials, or supplies in connection with the performance of this Agreement, and from any and all claims and losses accruing or resulting to any person, firm or corporation who may be injured or damaged by Grantee in the performance of this Agreement.

- 8. In the event of a dispute, Grantee shall file a "Notice of Dispute" with the State Library within ten (10) days of discovery of the problem. Within ten (10) days, the grant monitor shall meet with the Grantee for purposes of resolving the dispute. Any dispute concerning a question of fact arising under the terms of this Agreement which is not disposed of within a reasonable period of time by Grantee and State employees normally responsible for the administration of this Agreement shall be brought to the attention of the State Librarian or designated representative of each organization for resolution. The decision of the State Librarian or designated representative shall be final. In the event of a dispute, the language contained within this Agreement shall prevail over any other language including that of the bid proposal. The existence of a dispute not fully resolved shall not delay Grantee to continue with the responsibilities under this Agreement which are not affected by the dispute.
- 9. Federal and State Taxes: The State Library shall not
 - a. Withhold FICA (Social Security and Medicare payments) from Grantee's payments or make FICA payments on the Grantee's behalf; or
 - b. Make Federal or State unemployment insurance contributions on Grantee's behalf; or
 - c. Withhold Federal or State income taxes from Grantee's payments

Grantee shall pay all taxes required on payments made under this Agreement including applicable income taxes and FICA.

- 10. Fringe Benefit Ineligibility: Grantee agrees that neither the Grantee nor its employees and contract personnel are eligible to participate in any employee pension, health benefit, vacation pay, sick pay or other fringe benefit plan of the State of California.
- 11. Workers' Compensation: The State of California will not provide Workers' Compensation insurance for Grantee or Grantee's employees or contract personnel. If Grantee hires employees to perform services required by this Agreement, Grantee shall provide Workers' Compensation insurance for them.
- 12. Non-Discrimination Clause: During this grant period, the Grantee and the Grantee's subcontractors shall not unlawfully discriminate, harass, or allow harassment against any employee or applicant for employment because of sexual orientation, race, color, ancestry, religious creed, national origin, physical disability (including HIV and AIDS), mental disability, medical conditions (cancer), age (over 40), marital status, and denial of family care leave. Grantee shall insure that the evaluation and treatment of contractors, employees and applicants for employment are free from such discrimination and harassment.
- 13. Exclusive Agreement: This is the entire Agreement between the State Library and the Grantee.

- 14. Severability: If any part of this Agreement is held unenforceable, the remainder of the Agreement will remain in full force and effect.
- 15. Applicable Law: The laws of the State of California govern this Agreement.
- 16. Notices: All notices and other communications in connection with this Agreement shall be in writing, and shall be considered delivered as follows:
 - a. When delivered personally to the recipient's address as stated in this Agreement;
 - b. Three days after being deposited in the U.S. Mail, postage prepaid addressed to recipient's address as stated in this Agreement
 - c. When sent by Fax or e-mail to the last Fax or e-mail address of the recipient known to the party giving notice. Notice is effective upon receipt.

PAYMENTS, REPORTS AND CLAIMS

LIMITATION OF EXPENDITURE

Expenditure for all projects must conform to the approved budget, as amended, and with applicable Federal and State laws and regulations.

Any of the sums listed as approved and/or amended appearing under the categories in the approved budget may be adjusted with prior authorization from the State Library grant monitor. This would be to increase any allotment not more than 10% with the understanding that there will be corresponding decreases in the other allotments so that the total amount paid by the California State Library to the Grantee under this Agreement shall not exceed the awarded amount, which shall be expended/encumbered during the grant period.

PAYMENTS

Payment will be provided to cover the expenditures incurred by the Grantee for the project in the following manner:

- Initial Payment of 90% of Approved Award Amount (\$119,379): upon execution of the agreement and submission of claim and certification by Grantee.
- Payment of 10% of Approved Award Amount (\$13,264): on project completion and upon the submission of required final narrative and financial reports, no later than June 30, 2022.

If the amount of payment made by the California State Library shall exceed the actual expenses during the term of this agreement, as reflected in the financial reports to be filed by the Grantee, the Grantee shall refund to the California State Library the amount of such excess payment.

REPORTS AND CLAIMS

The Grantee shall make all required reports and claims to the California State Library.

- I. The Grantee shall be responsible for the submission of interim and final narrative and financial reports on the progress and activities of the project, to the California State Library. - III. The final 10% of the grant award is payable only if the Grantee is on schedule to fulfill all project requirements in the time specified in the award. The project grant monitor must also approve the project reports. Failure to provide timely reports is a breach of a Grantee's administrative duty under the award, which may result in State audit exceptions against the State and the loss of grant funds. The State Librarian may extend the final deadline for good cause. Request for extension beyond the ending date of the grant period, must be received at least 30 days prior in writing to that deadline by the grant monitor.

Statement of

Families benefit from improved knowledge of resources and Need/Problem/Aspiratiopportunities to engage in prevention activities such as reading, immunizations, healthy meals and high. quality child care. However, there are still families experiencing social and economic barriers such as mental health, substance abuse, and domestic violence.

> The First 5 El Dorado Commission has invested in core early childhood supports and services that increase community, based access through Community Hubs. Each Hub has a team that includes an Early Childhood Literacy Specialist, Family Engagement Specialist, Community Health Advocate and Public Health Nurse with the common goal to increase resiliency in families. Each Hub offers activities focused on early literacy and reading, child development and parenting, and preventative health services, all at no cost to the families. This is best reflected in the libraries' early learning centers. supporting early care and education providers, and increasing access to family engagement opportunities such as support groups, parenting classes, and early literacy groups. (Kathi Guerrero, First 5 **Executive Director)**

However, rural, isolated and underserved communities as well as communities with hard-to-reach and at-risk populations are still not being reached by Hub services. These include home-based care providers, FFN (Family, Friends and Neighbor) providers, and communities like Georgetown (Hub 4).

In Georgetown, 14% of children live in poverty, and the unemployment rate is 10%. Of the 15,905 households in Hub 4, 4,143 (26%) have children 0-18. Of the 472 grandparents living with their own grandchildren, over a third (35%) of those are responsible for their care. The Public Health Nursing Community Needs Assessment identifies challenges for Hub 4 families including risk of substance abuse, mental health, safety, health disparities, dental disease and homelessness, inadequate nutrition, and the need for life skills and family supports. Service priorities in Hub 4 are to concentrate outreach efforts to low-income families, preventative education. parenting, supports for grandparents raising grandchildren, nutrition. employment development, services for children with disabilities or other special needs, and early care and education services for children not enrolled in preschool.(Assessment Report).

Vast disparities exist and mobile services are desperately needed to meet the needs of families where they are--trailer parks, parks, WIC centers, and at community events. In addition, all throughout El Dorado County, home care providers and grandparents are caring for children in isolation. It is the mission of the El Dorado Libraries to provide access to wraparound services for these families.

Project Design

First 5 El Dorado has chosen to implement Community Hubs through local libraries with schools as a mechanism to facilitate early childhood community services that align with the Strengthening Families Framework and its three key "levers for change." The focus

for Community Hubs is prevention – through early identification of developmental issues, targeted assistance, and efficient service delivery for expectant parents, children birth through 5, and their families F5 El Dorado Strategic Report.

Early Childhood Literacy Specialists working with Family Engagement Specialists would provide targeted outreach to home childcare providers using Dialogic reading early literacy curriculum and Lena Shared devices to maximize talking, reading, singing, playing and writing. LENA Start wearable technology is a program for caregivers that uses regular feedback from LENA technology to help improve talk in the home. Over the course of 10 weekly sessions, caregivers would learn about the importance of interactive talk along with ways to incorporate more talk into their daily routines. Regular feedback to caregivers on the early language environment has been shown to increase interactive talk and child language ability. (Gilkerson, Richards, et al., 2017a; Hernandez, 2011) Early language is the strongest single predictor of cognitive development. (Capute, Shapiro, & Palmer, 1987; Gilkerson & Richards, 2008; Hart & Risley, 1999) The amount of language a child hears affects brain processing speed and subsequent vocabulary acquisition. (Fernald, 2009, June; Saffran, Aslin, & Newport, 1996) Vocabulary at age 3, in turn, drives language and reading skills at age 9-10, which strongly predict high school graduation. (Hernandez, 2011).

In addition, home childcare providers would be encouraged to complete developmental screenings, including social emotional screens, for all of the children in their care. Access to Community Hub services would be provided, and educational resources and materials incorporated, along with best-practices for their use.

Georgetown Mobile Outreach would be conducted with a Chryler Pacifica Plug-in Hybrid van. This vehicle would be outfitted with Mifi and Pop-up Program equipment and wrapped in the first few months of the grant. Community Outreach Sites would include Buckeye Trailer Park, Otter Creek School, Mountain Kids Co-Op Preschool. WIC center, and two parks in remote areas, as well as community engagement events. Discussions with these sites have already occurred and they are eager to begin. Materials on the Mobile Vehicle would include props, felt board, basket of books, sensory tubs and large motor activity materials. Laptops and Mifi connectivity would be provided for parent/caregiver use to access services with Hub partners, and connect to the internet for email, job searches, and training. This is a vital service as many areas in Georgetown are without internet access/capability. STEAM materials and activities for school age children would also be included, and the Community Health Advocate would provide lessons on healthy cooking and snacks.

Reduced isolation, self-efficacy and increased access to resources are high quality support outcomes providers and families gain when actively participating in the evidenced-based dialogic early literacy instruction, connection to Hub services, and social-emotional learning support.

Experience and Planning

Collective impact occurs when organizations from different sectors agree to solve a specific social problem using a common agenda, aligning efforts, and using common measures of success. It's an innovative and structured approach to making collaboration work across government, business, philanthropy, non profit organizations and citizens to achieve significant and lasting social change.

Community Hubs are seen as a tool to facilitate early childhood community services that align with the Strengthening Families Framework and five protective factors. Each Hub is a collection of program and service providers who believe that by working together; libraries, schools, early education, health, human services and business can better strengthen children and families.

Community Hubs are a partnership between First 5 El Dorado, EDC Library, EDC Early Care and Education Planning Council, EDC Child Abuse Prevention Council, EDC Health and Human Services Agency's Maternal Child and Adolescent Health Program and Mental Health Services Act.

Community Hub Teams have been established to build resilient families with protective factors: connections, knowledge, understanding, resilience and concrete support.
•Increasing access to services.

- Applying trauma informed approach.
- ·Establishing trust and building relationships.
- Offering opportunities to build knowledge and awareness.
- Providing services reflecting the cultural diversity of the

communities they serve.

•Using data to inform local priorities.

Each Hub has a team that includes an Early Childhood Literacy Specialist, Family Engagement Specialist, Community Health Advocate and Public Health Nurse with the common goal to increase resiliency in families. Hubs offer activities focused on early literacy and reading, child development and parenting, and preventative health services, all at no cost to the families.

In El Dorado County, one in four families with children under the age of five visit libraries making it the most accessible public service for children. In FY 17-18, over half of the families participating in Hub programming (78%) reported they or another family member read stories or looked at picture books with their child every day, one of the highest rates in the state.

Utilizing the Public Health Nursing Community Needs Assessment, we are ready to reach out to the most vulnerable of our families with young children, and we must be mobile so that we can meet them where they are. Evidence-based dialogic early literacy instruction at home care provider sites, interactive grandparents groups, and on the ground hub teams working with families in their neighborhoods are our next steps to meet the outlined goals of our assessments.

Meeting the identified needs of our most vulnerable communities where they live, eat, and play with the acquisition of a mobile vehicle and the development of need-based, evaluated best-practices service models will allow these programs to flourish. We currently have established funding for mileage costs for a personal vehicle to do early learning outreach. These funds will be utilized to cover the mileage costs of our new hybrid mobile vehicle for a wide variety of onsite learning programs and community outreach events, and there will be no fuel costs as the EV charging stations from the County are free. The mileage costs will be paid to Fleet, and they will provide maintenance, repair, and vehicle replacement (at end of vehicle life). We will use this comparative data to apply for additional funding for Hybrid vehicles for the rest of our team with the assistance of our Air Quality Management District.


COMMUNITY PROFILE

The Public Health Nursing Community Needs Assessment identifies challenges for Hub 4 families including risk of substance abuse, mental health, safety, health disparities, dental disease and homelessness, inadequate nutrition, and the need for life skills and family supports. The Community Hub Profile Report builds upon these findings offering service priority considerations.

SERVICE PRIORITIES

The service priorities in Hub 4 are to concentrate outreach efforts to low-income families, connect with atrisk youth and adolescents, and reach out to families who have children with disabilities. Strategies to consider include preventative education, teen engagement, parenting, mobile dental services, supports for grandparents raising grandchildren, nutrition, employment development, services for children with disabilities or other special needs, and early care and education services for children not enrolled in preschool.

DEMOGRAPHICS



There are 40,718 people in Hub 4.

- Of the 8,964 children ages 0-19, 30% are 15-19, 30% are 10-14, 24% are 5-9 and 16% are under the age of 5.
- 93% of people are White, <1% Black, 1% American Indian, 2%
 Asian/Pacific Islander and 4% Multiracial. Of the total, 8% identify as Hispanic or Latino.
- 8% of families speak a language other than English.

FAMILIES

Of the 15,905 households in Hub 4, 4,143 (26%) have children 0-18.

- The average family size is 2.92.
- Of the 472 grandparents living with their own grandchildren, over a third (35%) of those are responsible for their care.



ECONOMICS



The median family income in Hub 4 is \$87,057.

- The average unemployment rate for individuals within Community Hub 4 is 10%.
- 5% of families live in poverty, while 14% of children live in poverty.

HEALTH

92% of Hub 4 residents have Health Insurance Coverage.

- 76% (or 30,988) of those with coverage hold private health insurance.
- 34% (or 13,717) have public health insurance coverage.
- 8% (or 3,185) of the population have no health insurance, 13 of which are under the age of 6, and 271 are ages 6-17.
- A total of 5,454 people within the Community Hub 4 service population have a disability, of which 281 are under age 18.



EDUCATION



94% of Hub 4 residents are high school graduates or higher.

- 29% (or 8,653) have a bachelor's degree or higher.
- There is insufficient ECE capacity 1,115 slots for 1,416 children ages 0-5.
- There are 10 licensed child care centers serving 287 children and 10 licensed child care homes serving 88 children.

IMPORTANCE OF RESILIENCE

Positive interactions are the foundation for healthy brain development at any age. When children are exposed to prolonged and frequent (toxic) stress responses, and lack caring relationships, their brain development can be damaged. Resilient families are better prepared to address toxic stress and are essential to healthy communities.

In the absence of a caring relationship, toxic stress can disrupt healthy brain development. Research tells us the higher number of adverse childhood experiences (ACEs) resulting from toxic stress impacts health outcomes. People with high ACE scores are more likely to be violent, to have more divorces, more broken bones, more drug prescriptions, more depression, and more autoimmune diseases. Currently, El Dorado County exceeds the state in the number of domestic violence calls for assistance per 100,000 adults (685.7/415.6), substance affected still or live born infants per 1,000 (45.4/23.4) and mental health diagnoses in pregnancy (129.7/48.5).

Building family relationships is essential to healthy communities. Community Hub Teams have been established to empower families to address stressors before they become toxic.

HUBS BUILD RESILIENCE

Each Hub has a team that includes an Early Childhood Literacy Specialist, Family Engagement Specialist, Community Health Advocate and Public Health Nurse with the common goal to increase resiliency in families. Each Hub offers activities focused on early literacy and reading, child development and parenting, and preventative health services, all at no cost to the families.
