


Dear El Dorado Union High School Board,

A panel expert for Orange County, Dr. Mark McDonald, a psychiatrist who specializes in children and at-risk youth, may have summed it up best: "Children are not dying from Covid-19. Children are not passing the disease on to adults. So the only question is, "Why are we even having this meeting tonight?" We're meeting because we adults are afraid. As parents, we will face many moments of anxiety: seeing our children off on their first day of kindergarten, their first day of camp, their first year of college. We may want to keep them home to protect them from the world, which can indeed be a frightening place. But let's be clear, when we do that, we are not really protecting our children. We are only attempting to manage our own anxiety, and we do that at their expense. We are acting as negligent parents. We are harming our children. We are failing them. We must agree to make decisions in the best interest of the children. If we do not – if, paralyzed by fear, we continue to act purely out of self-interest – we will ensure an entire generation of traumatized young adults, consigned to perpetual adolescence and residency in their parents' garages, unable to move through life with independence, courage, and confidence. They deserve better — we owe it to them as parents."

During the board meeting on the 21st it was stated that 318 families had signed up for distance learning. I don't know a total number of students for all the highschools, but that seems like a low % of students because of fear, or health concerns opting for distant learning. This is key to understanding that the majority of families would return to the classroom. You have done your duty offering these families distance learning. So don't hold our kids back because of the fear of opening, it has been shown a threat is very very low. Distance learning is not a viable option and should be acted upon with our children's best interest in mind. Opening of schools is a key component to our country's economic recovery.

As a 4-H program Representative, I can share with you a new survey which polled over 1,500 youth between the ages of 13-19 nationwide, was commissioned by National 4-H Council and conducted by The Harris Poll during the pandemic. I will share with you some of the outcomes as I believe they are very important.

- 65% of those surveyed say uncertainty about the future makes them feel anxious or depressed
- 71% of those surveyed say school work makes them feel anxious or depressed
- 67% feel pressure to keep feelings to themselves
- 67% pretend to feel better to not worry anyone
- 65% deal with my feelings on their own
- 82% of teens are calling on America to talk more openly and honestly about mental health issues in this country
- 79% of teens surveyed wish there was an inclusive environment or safe space for people in school to talk about mental health. 70% wish their school taught them more about mental health and coping mechanisms
- 55% of teens say they've experienced anxiety, 45% excessive stress, and 43% depression

I can provide the full report if anyone would be interested. Please feel free to reach out to me. I will wrap up as I know your time is valuable. We need to put forth the effort and reopen our schools on August 10th. There is no greater risk then the isolation and loneliness our students have faced since March.

Supervisor Hidahl, Dr. Williams, and Dr. Manansala,

I reside in El Dorado Hills and have four children (grades K, 2, 4, and 6) in the Buckeye Union School District.

Our current school reopening plans rely on prompt testing. At present, testing is essentially non-existent outside of emergency and hospital settings. Even when I got tested in June, I waited six days for my result. Now, one of my family members has been waiting for a test result for 19 days and is still waiting. Measures like closing individual classrooms and testing close contacts are therefore unavailable. If a child or staff person gets a fever, a headache, or even just a cough, we can't simply isolate that person (or even a whole class) for a day or two while we wait for test results because results are taking weeks to get. In the absence of prompt test results, every episode of symptoms will require at least a 14-day quarantine for all contacts.

During a typical school year, our family and our school community go through several rounds of illnesses. In the absence of prompt testing, teachers and administrators will be under pressure to look the other way when a student or staff member shows symptoms, knowing that reporting a potential case of Covid could result in closing an entire school site for at least two weeks. Moreover, the problem of asymptomatic transmission means that routine testing of school staff is essential. Again, lack of prompt test results renders routine testing ineffective.

Many suggest that Covid-19 simply isn't that dangerous. The idea is that we shouldn't worry about testing because the virus will inevitably permeate our community, and we should simply let it run its course. But although we cannot, and should not, shield our children from every risk, the Covid-19 risk is unique. This is not like giving our kids bicycles knowing they will sometimes fall and get hurt. The Covid-19 risk is different, both in type and in magnitude.

For example, whereas flus are relatively well-understood, Covid-19 is a new disease with potentially permanent respiratory effects. Also, many with Covid-19 are not experiencing immediate respiratory symptoms but rather are experiencing other problems, such as stomach illnesses, several weeks after exposure. These effects are not well understood. We therefore should resist the temptation to assume that this is just another minor illness and that our children are not at risk of serious long-term harm.

These risks can be substantially reduced by adopting techniques used in other districts, in some universities, and in other countries, such as incorporating distance learning and independent study, bringing students to campus only in small

groups, teaching in outdoor settings, and using staggered arrival and departure times.

No one contends that such techniques are ideal, but such techniques can be part of a well-reasoned, systematic approach --- rather than requiring teachers, administrators, and parents to make day-to-day epidemiological decisions without necessary training and expert guidance. Without prompt testing and without rethinking our options for on-site instruction, there can be no safe reopening of school sites.

For these reasons also, if El Dorado County is on the state monitoring list at the time that schools are scheduled to open, schools should not seek or be granted waivers from State restrictions barring reopening classrooms --- such waivers should be considered only if, among other things, testing capacity is proven and physical distancing is mandatory.

I ask that the County and our communities consider these factors and options and consider also that, now as well as many years from now, our communities and our loved ones will judge whether we simply jumped to convenient conclusions or whether we did our best to proceed based on informed expertise and clear, rational guidance.

I believe the School Board and El Dorado County's BOS have the duty, not to take the lazy way out beginning this school year, distance learning. These kids belong with their peers. I attended the EDUHSD board meeting on July 21st where it was stated, distance learning would be different this year. I find it very hard to believe this could be the case, especially when teachers are asking for extra time because they're not ready. Distance learning is a huge band-aid that it's not working. My daughter will be entering her senior year at Union mine High School. She's one of the school's best students. Taking AP courses last year and even through the pandemic maintaining a 4.25 GPA. Her AP English class was supposed to help her become a better writer to get ready to enter College. There was very little instruction and just a few written papers with zero feedback, and no real help from her teacher on how to write them. She said it was a waste of her time. The whole reason to take the course was to become a better writer, not for busy work and to prepare her for college. When she found out that distance learning would be how the year is starting, she said, "what a joke, I might as well take the two courses I need and be done." Mind you she planned to take a full course load this coming year, six of her seven classes being AP courses. Breaks my heart she is so disappointed in her offered education she would just check out this year. I believe you will see this with many seniors. You will lose attendance and many will just graduate early unless we get them in the classroom. The setback to our youth is unmeasurable. What a shame to throw away this year because you are letting a political year stand in the way of our children's education.

You might say what politics, but data is showing that politics must be driving your decisions. Data shows 0-17 make up only 9% or of our total cases in El Dorado county for the entire period of March-July 25th. If you take out of our numbers, the Tahoe cases alone, you would see we have a very small % of cases and only one death since March. You know that Tahoe is a very long distance from most of our schools in the county. This unique population could be considered on a seperate opening plan and really shouldn't hinder the High Schools in which you serve. Orange County Board of Education is fighting back against the governor and will reopen their schools. Where is your backbone for these kids? I think it is a very lazy and not a scientific way to not open our schools, by stating "The County has not been provided sufficient testing resources from the State to safely support thousands of students and staff returning to school on August 10. They are aggressively seeking resources. We will start on August 10 distance learning and return in person as soon as safe and meet the State guidelines." What does that even mean? You need to explain what this means, and understand that your lack of planning doesn't not give you the right not to open the schools. What is your timeline, what is your plan to get these things done. We demand answers. You need to figure out what that testing resource is and get it done, period. Return in person as soon as it is safe? It is currently safe per CDC and the American Academy of Pediatrics.

There's no question that children generally represent the lowest risk cohort for Covid-19. The American Academy of Pediatrics concludes: "SARS-CoV-2 appears to behave differently in children and adolescents than other common respiratory viruses, such as influenza, on which much of the current guidance regarding school closures is based. Although children and adolescents play a major role in amplifying influenza outbreaks, to date, this does not appear to be the case with SARS-CoV-2. Although many questions remain, the preponderance of evidence indicates that children and adolescents are less likely to be symptomatic and less likely to have severe disease resulting from SARS-CoV-2 infection. In addition, children may be less likely to become infected and to spread infection. Policies to mitigate the spread of COVID-19 within schools must be balanced with the known harms to children, adolescents, families, and the community by keeping children at home."

Thank you so much for your continued work you are doing for your community. It is appreciated.

The EDC Republican Party believes that it is imperative that County re-open its public schools. For the well-being of our children's socio-emotional health and scholastic development/achievement, our Party believes the benefits of attending school in-person outweigh the risks to our children.
