I am a teacher and a parent in El Dorado Hills. I am writing to express my concerns about the current plans to reopen schools.

The current plan in my district (to reopen 5 days) does not try in even the slightest to socially distance students from one another nor teachers from students. From the beginning of the pandemic, it has been broadcast that socially distancing can help reduce the spread of Covid-19, yet now our district is planning to ignore this essential strategy as we enter the classrooms. Hello Supervisor Hidahl,

I understand the Board of Supervisors has some influence over whether to open schools this fall. Apparently, Dr. Nancy Williams owns the ultimate decision, but my family wants to give you our thoughts on this important call. Closing schools to in-person learning would be a big mistake for a number of reasons:

1. COVID is not a death sentence. It's essentially the flu in terms of how it impacts healthy people. As you likely know, the effect on young people is even more benign. Unless we plan to shut down school every flu season going forward - there

is no rationale to do it now.

- 2. The costs of not going to school far outweigh the risks of opening school. The societal costs include increased suicide (at record highs currently), depression, loneliness, etc. Kids need to be in school to see their friends and grow in their ability to interact with each other and actively exchange ideas. Zoom doesn't allow this.
- 3. Europe has been in school for over a month with minimal health impact! Look it up. Europe is proving my point in real time.
- 4. Without in-class instruction, the education gap will grow, perhaps irreversibly, between the poor and the middle and upper classes. The poorest are suffering with school closed more than the well-off. Additionally, the poor single-parent homes cannot get back to work full time until their children are back in school full time further damaging them economically.
- 5. Student-athletes will be cheated of their seasons especially the seniors. They'll be denied their final year of competing or attempting to qualify for college-level teams. Note that last year's juniors will essentially miss two years of sports. It's unfair to cancel athletics when many are automatically socially distanced (e.g. baseball, swimming, tennis, etc.). What a terrible way to complete their high school careers.

Last, in-person instruction should be the default position for the reasons above. The onus should be on Dr. Williams to demonstrate why our kids should not attend school on site. Further, El Dorado County is a large county. Schools such as Oak Ridge and Ponderosa should not be shut down because of outbreaks near Lake Tahoe. If for some reason, the county surpasses the state's watch list threshold due to cases in the eastern part of the county, we should seek and receive a special exemption.

In the past Lori Parlin and Larry Weitzman have accompanied me to meetings with county counsel concerning the county's systematic lack of response to Public Record Act Requests. This just goes to prove how last week's 3.5 hour Special Joint BOS-Planning Commission meeting was just another dog-n-pony show, a total waste of time and taxpayer resources. In regard to CPRA 2709 and 2645, my original CPRA was edited by the Clerk to the Board, very likely under the direction of County Counsel, and in so doing key elements were eliminated from my requests for public records. Such Bureaucratic Shenanigans CANNOT be tolerated.

Of particular concern is Deputy Toney's report Case File EG20-5423 which was also to be sent to Planning Director Tiffany Schmid, along with all other complaints, pursuant to the River Management Plan. Responses to the aforementioned CPRAs were due respectively June 9th and July 17th.

Apparently EDC public officials have no intention of operating lawfully with transparency and accountability. It does not bode well that Lori Parlin has been particularly unresponsive to constituent concerns about public safety in the Coloma-Lotus region. I've specifically requested if the requested documents do not exist, or you intend to withhold them, please so state immediately. The agency must justify the withholding of any record by demonstrating that the record is exempt or that the public interest in confidentiality outweighs the public interest in disclosure. (§6255) If you determine that some but not all of the information is exempt from disclosure and that you intend to withhold it, I ask that you provide a signed notification citing the specific legal authorities on whom you rely. It was further requested that your determination be made within 10 days, or sooner, as stipulated within the California Public Records Act, Government Code 6253(c).

*Note these time periods may not be used solely to delay access to the records. (§ 6253(d)) The law makes no provision for extensions due to Covid-19.

So what's the problem? Pursuant to the Brown Act Section § 54954.2(a), you are required to respond publicly to this inquiry by law.

Lori Parlin has an obligation to respond to her constituents. Lori? (TOTAL SILENCE)

Your silence is your acquiescence that you have no intention of abiding by the law.

Records Requested: Therefore, pursuant to California Public Records Act (Government Code Section 6250 et seq.) I request the following: Since Sheriff D'Agostini has threatened me for the exercise of my First Amendment rights and unlawfully deprived me the right to email EDSO staff, Deputy Toney advised me to email this request to the appropriate staff in order to obtain a copy of Case File 20-5423. His report should be emailed to me immediately upon the submission by Deputy Toney. A copy of this report should also be filed with Planning and Development Director Tiffany Schmid and to Supervisor Lori Parlin to ensure appropriate follow up as per the RMP: Note Section 2.4.2 "During weekend days, on-river staff will provide patrol and respond to safety, trespass, and noise issues. Boat counts and coordination with the Sheriff related to trespass and illegal parking incidents will be conducted by on-shore staff." Section 2.5 states: "The Sheriff's Department will remain the lead agency for river emergency response. The Sheriff's Department will continue its river regulation and law enforcement functions, and coordinate with the El Dorado County Fire Protection District and RSC in all river rescue planning and response functions." Section 4.8.1: "Observed or reported violations of Quiet Zone regulations or County noise standards will be reported to the County Code Enforcement Officer or the Sheriff's Department, as appropriate, within 2 working days of the occurrence," Section 4.8.2: "More than two noise exceedance citations per year issued to SUP holders may result in a formal hearing considering the noise exceedances and the possible imposition of fines and other disciplinary measures on violators."
