

AGREEMENT FOR SERVICES #4800

This Amendment I to that Agreement for Services #4800, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Northern California Construction Training, Inc, a California nonprofit corporation, duly qualified to conduct business in the State of California, whose principal place of business is 10411 Old Placerville Road, Suite 205, Sacramento, CA 95827, (hereinafter referred to as "Contractor");

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide instructors, services, and materials necessary to provide a pre-apprenticeship program to increase the skillsets of the clients of the El Dorado County Probation Department so that they may become more successful and productive members of the public upon release, in accordance with Agreement for Services #4800, dated May 19, 2020, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to increase the not-to-exceed amount of the Agreement, and update the billing rates in accordance with "Exhibit A," as mentioned in the second paragraph under ARTICLE III of the Agreement, hereby amending **ARTICLE III Compensation for Services**; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #4800 shall be amended a first time as follows:

**ARTICLE III**

**Compensation for Services:** For services provided herein, including any deliverables that may be identified herein, County agrees to pay Contractor upon the satisfactory completion and County’s acceptance of work, monthly in arrears and within thirty (30) days following the County’s receipt and approval of itemized invoice(s) identifying services rendered.

For the purposes of this Agreement, the billing rate shall be in accordance with “Exhibit A,” incorporated herein and made by reference a part hereof.

Total amount of this Agreement shall not exceed \$222,732.24.

Itemized invoices shall follow the format specified by County and shall reference this Agreement number on their faces and on any enclosures or backup documentation. Copies of documentation attached to invoices shall reflect Contractor’s charges for the specific services billed on those invoices. Invoices shall be mailed to County at the following address:

In the event that Contractor fails to deliver the documents or other deliverables required by the scope of services pursuant to this Agreement, County at its sole option may delay the monthly payment for the period of time of the delay, cease all payments until such time as the deliverables are received, or proceed as set forth herein below in **Article XI, Default, Termination, and Cancellation.**
