I have scanned Table 10 from this report, see attached. As you will see Campfires account for only 4% of causes of fires in this data, however they account for 54% of total acres burned.

I hope that this information will be helpful in your discussion and decision making process.

Fires spread uphill and a temporary campfire ban for the Coloma Lotus Valley will protect much more than just our valley.

As we've all seen, the fire danger in California has continued to increase and the Truckee area is no exception. **California has seen 9 of the 20 most destructive fires in California's recorded history in the last 5 years!**

The build-up of dry fuels, a significant drought and more people moving to and visiting the wildland urban interface have led to this extreme fire danger that threatens our community. **Many of the visitors to our region don't understand the danger, adding to the risk of an escaped campfire.**

Each year the Fire District responds to unattended or improperly extinguished residential campfires that escape the fire ring and start a wildfire. If this happens on a windy day a wildfire could be devastating to our community. **That is why the Truckee Fire Protection District is implementing a District-wide ordinance to ban backyard type campfires during fire season.**

EFFECTIVE THIS FIRE SEASON
(Starting in June)

- **No wood or charcoal fires**
- **Report illegal fires by calling 911**
- **Fire season usually runs from June -November**

***PLEASE NOTE** - *The fire ban does not include gas appliances like gas BBQ's, gas fire pits, pellet burning devices. Campgrounds and Day-use picnic areas are exempt.*

FREQUENTLY ASKED QUESTIONS (FAQ)

What is banned?

Residential campfires/bonfires that burn anything other than gas and BBQ's that burn solid fuel like charcoal briquettes, wood or lump charcoal including the Big Green Egg type.

Gas campfires, gas portable fire pits, gas BBQ's, pellet burning devices.

Who is exempt?

Designated campgrounds and day-use picnic areas, private campgrounds and community picnic areas with a valid permit, outdoor special event/commercial cooking operations with a valid permit.

Will the ban start when CalFire announces fire season for the entire state?

Yes, typically starting in June and ending after we get significant moisture, usually in November.

Can people use a briquette fuel-based smoker?

No, the issue being that there are briquettes being used and there still exists a risk of improper disposal of charcoal remnants.

Can people use a wood pellet fuel-based BBQ/smoker?

Yes, pellet burning devices are well contained and fully consumed to ash with no super-heated particles remaining that could start a fire after disposal.

Can people add wood shavings, like apple wood and other types you can buy for added flavoring, to a smoker or gas grill?

No, the addition of wood shavings will present a similar risk of incomplete combustion and improper disposal that can start a wildfire.

Would the district consider issuing briquette BBQ permits to individual residents?

No, with over 15,000 residential structures in the district, there is no logistical/financial way we could inspect, issue, or enforce permits of that magnitude.

Will permits be issued for picnic areas and special events/commercial cooking operations that use briquette/wood BBQ's?

Yes, these operations will be inspected for safe practices and issued a permit with specific operating guidelines.

- In effect during the Cal Fire burn suspension each year. Typically June-November each year.
- Supported by local HOA's, Town of Truckee, County Ordinance, Regional Fire Chiefs, and Cal Fire.
- Truckee Fire District has experienced a number of escaped fires caused by improper charcoal ash disposal and campfires.

Ordinance 04-2019: Banning Open Burning, Recreational Fires and Charcoal BBQ's during High Fire Conditions

FREQUENTLY ASKED QUESTIONS (FAQ)

PRINTABLE FIRE BAN FLYER

What is banned?

Residential campfires/bonfires that burn anything other than gas. BBQ's that burn solid fuel like charcoal briquettes, wood or lump charcoal including the Big Green Egg type.

What is allowed?

Outdoor gas devices including campfires, gas fire pits, gas BBQ's, pellet burning devices.

Who is exempt?

Designated state and federal campgrounds/day-use picnic areas, private campgrounds and community picnic areas with a valid permit, outdoor special event/commercial cooking operations with a valid permit.

Will the ban start when Cal Fire announces outdoor burning suspension in our region?

Yes, typically starting in the month of June and ending after we receive significant moisture, usually in November or as determined by Truckee Fire Protection District.

Can people use a briquette fuel based smoker at their home?

No, the issue being that there are briquettes used and there still exists a risk of improper disposal of charcoal remnants.

Can people use a wood pellet fuel based BBQ/smoker (i.e., Traeger)?

Yes, pellet burning devices are well contained and fully consumed to ash with no super-heated particles remaining that could start a fire after disposal.

Can people add wood shavings, like apple wood and other types you can buy for added flavoring, to a smoker or gas grill?

No, the addition of wood shavings will present a similar risk of incomplete combustion and improper disposal that can start a wildfire.

Would the district consider issuing briquette BBQ permits to individual residents, like the burn permit or the campfire permit the Forest Service issues?

No, with over 15,000 residential structures in the district, there is no logistical/financial way to inspect, issue, or enforce permits of that magnitude.

Will permits be issued for special events/commercial cooking that uses briquette/wood BBQ's?

Yes, these operations will be inspected for safe practices and issued a permit with specific operating guidelines. For permits, please visit our [special events](#) page.

Will there be additional fire restrictions during extreme wind, red flag, events?

Yes, as in the past, ALL open flames will be restricted during Red Flag days.



Fire Prevention Order

Northern California District

Applegate Field Office

CA-320-20-01

Due to dry conditions, high fire danger, and a shortage of firefighting resources, the Bureau of Land Management (BLM), Applegate Field Office is amending Fire Order CA-320-20-01 to prohibit all uses of open flame on public lands managed by the Applegate Field Office. This order is issued under the authority of the **Federal Land Policy and Management Act of 1976 (43 U.S.C. 1701, et. seq.)** and pursuant to **43 CFR §9212.2**. This open flame prohibition is in effect starting Sept. 8, 2020 until further notice. All other provisions of Fire Order CA-320-20-01 remain in effect until further notice.

Acts prohibited and defined under this order:

- Setting, building, maintaining, attending, or using a campfire, charcoal BBQ, portable stoves, or open flame of any kind is prohibited including within established campground.
- Smoking, except within an enclosed vehicle or camp trailer or while stopped/standing in a designated developed campground with a three-foot diameter area barren or cleared of all flammable materials and away from federal facility doors, windows and air ducts.
- The possession or operating of any welding, acetylene device or other open flame torch that uses oxygen and fuel gases to weld and cut steel or metallic components. Welding and torch definitions and direction pursuant to 43 CFR §912.2, U.S. Department of Labor- Occupational Safety and Health Administration 1910.252(a).
- Possessing, discharging, using or allowing the use of fireworks, pyrotechnic or incendiary devices.
- Shooting, igniting or causing to burn; explosives or explosive material, including binary explosive targets.

Exemptions:

Pursuant to **Title 43, CFR §9212.2**, the following persons are exempt from this order: **Anyone with a special-use permit, specifically authorizing the otherwise prohibited act or any Federal, State, or local Officer, or member of an organized rescue or firefighting force in the performance of an official duty.**

Penalties for violating this order:

Anyone who is found guilty of violating a fire prevention order, which may be classified as a Class A Misdemeanor Offense under 43 USC 1733(a) FLPMA, 18 USC 3559, and 18 USC 3571 Sentence of Fine - Sentencing Reform Act, Oct. 12, 1984, that does not result in death, may be fined not more than \$100,000 and/or imprisonment for not more than 12 months, or in accordance with the applicable provisions of 18 USC 3571. Restitution for total fire suppression and damage costs incurred may be borne by the trespasser.

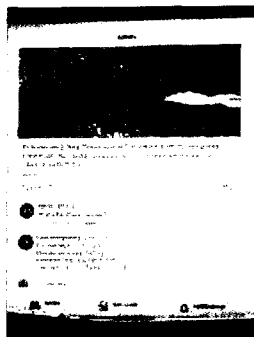

Ms. Parlin,

As you are aware by postings on CLNews, there was another open campfire reported last night at the Coloma Resort directly across from Brockman's driveway on Bayne Road. It was the same location where I took the below pictures yesterday. Take a close look at the thick smoke and crowds at the Coloma Resort. ***Should there be another fire ignited on historic Mt. Murphy, my home and beloved pets would be the first in line of danger.***

My next door neighbor, Bob Brockman, died two years ago and the property has since been vacant. The current listing agent of Brockman's property, Marilyn Goff, is required **by law** to disclose "undesirous issues affecting marketability" to prospective buyers such as noise/fire/public safety issues at the Coloma Resort, including the hazardous road conditions and egress problems at the Mt. Murphy bridge in the event of another emergency. Marilyn Goff has been apprised of numerous reports made by neighbors to CA State Parks and EDC public officials concerning annual fireworks, exceptionally loud amplified events, and huge traffic jams at the Coloma Resort. She was also provided graphic photos of Mt. Murphy arson fires and incident reports at the obviously vacant Brockman property. In fact, it was Ms. Goff who informed me that she was concerned about drug dealing taking place at the Brockman property.

Over the years residents have circulated several petitions and filed complaints with the county over the Faieta's apparent disregard for public safety and county laws/ordinances. The Coloma Resort was the only campground

that refused to cooperate with those of us who met with county/state officials for the purpose of mitigating noise and related campground issues **as required under the River Management Plan.**

After I collected signatures petitioning the county for the Coloma Resort SUP revocation, the Faieta's made threats and eventually retaliated against me by submitting the attached libelous letter to the County. Note the absurd terminology Faieta used labeling me as "misguided", "unrestrained", "harassment", etc. I fortuitously obtained that letter along with other documents via a Public Record Act request. *They clearly demonstrate that the Faieta's have no intention of abiding by the law or in the best interests of the community. The Faieta's don't even live in Coloma!*

Since then EDC and State Parks have been uncooperative in lawfully responding to CPRAs. As you know, that was one of the purposes of our 2018 meeting with Assemblyman Frank Bigelow at his Capitol office. Other major concerns we discussed with Frank Bigelow were the number of Mt. Murphy arson fires and the ***overt threats, assaults and retaliation***, in particular, those made by members of the American River Conservancy, the River Mafia Mob, as well as past and present El Dorado County public officials. All the factual documents have been entered into the public record, which includes your own notarized affidavit concerning Sr. Services attorney Al Hamilton's threat made against me at a Taxpayers Association meeting.

When it comes to public safety, the Coloma Resort "can has been kicked down the road" for too long by county officials (such as Roger Trout and Tiffany Schmid) who've turned a blind eye and deaf ear to constituent concerns. Prior to being elected you accompanied me to numerous meetings with county officials as a witness to our discussions about the aforementioned issues. When you have knowledge of wrong doing, but fail to take remedial action, then you become complicit and *personally liable* for aiding and abetting the malfeasance.

For clarification, this is ***not*** a matter to be turned over to the American River Conservancy or the Coloma Lotus Advisory Committee who comprise the River Mafia Mob. It is incumbent upon you to personally take responsibility and address this public safety matter before it turns into a potential inferno jeopardizing residents on the northeast side of the Mt. Murphy bridge due to the Faieta's reckless disregard for the law.

I look forward to your timely response.

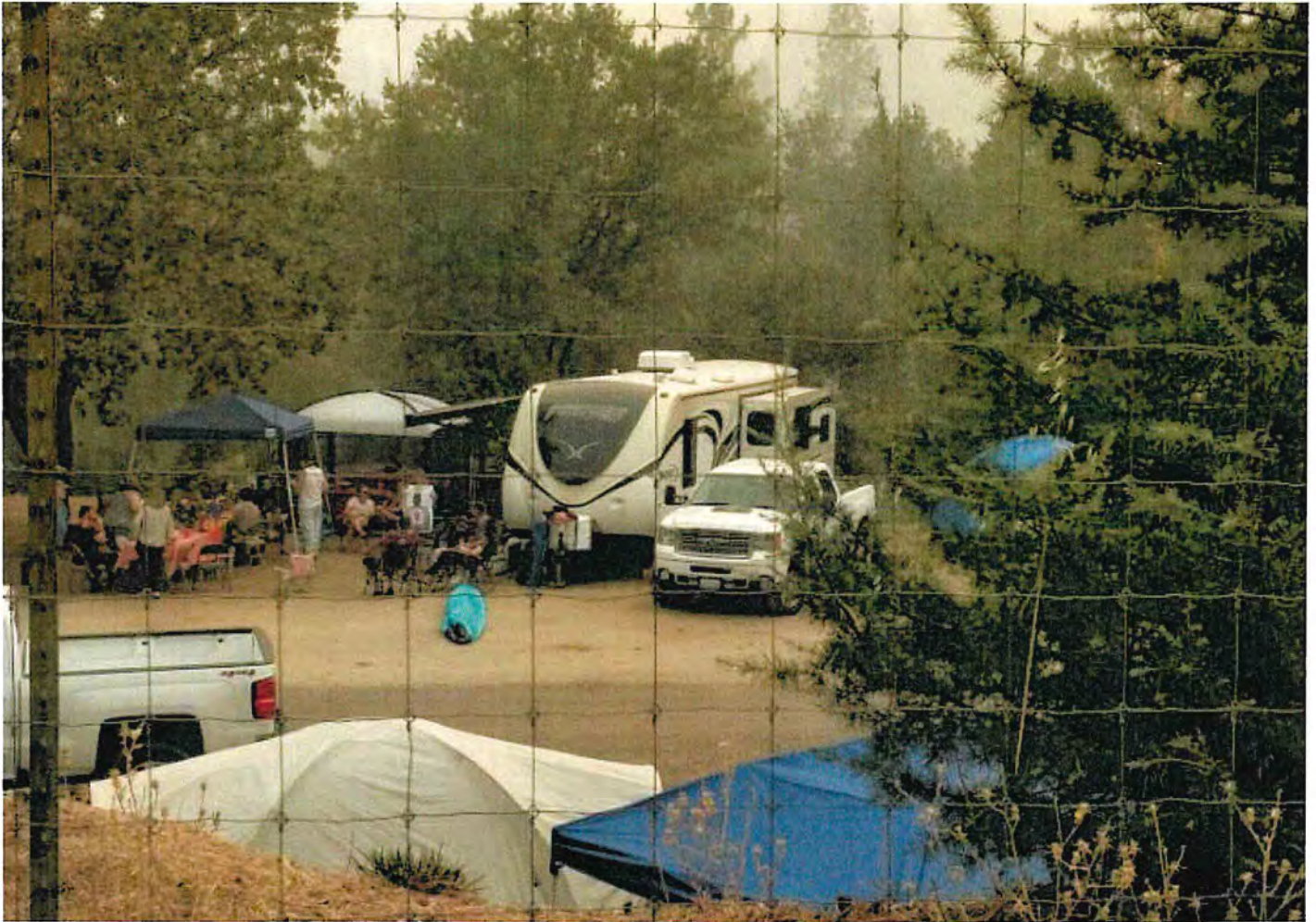

RE: Noise levels from Coloma Resort

Dear Mr. Faieta:

The Planning Department is aware that Coloma resort has been regularly utilizing amplified music, including karaoke, at the campground. The resulting noise levels are likely exceeding the noise standards of your special use permit. Condition 9 of special use permit S93-03 states:

The noise level of campground activities shall be regulated by the following dBA. At the property line:

10:00 p.m. to 7:00 a.m. – 50 dBA
7:00 a.m. to 10:00 p.m. – 60 dBA

Attached is examples of sound levels to give you a subjective description of the noise levels anticipated from various activities. Note that noise above a normal conversation would exceed the 60 dB threshold.

Please review your campground noise policies and ensure that your campground activities are planned in accordance with your special use permit conditions. It is recommended that you especially concentrate on noise activities which may be annoying to local residents, such as the use of P.A. systems, including karaoke.

Should neighbors file complaints with the County, it would be considered a violation of the special use permit. If you have any questions, please call me at 621-5355.

Dear Mr. Faieta:

A complaint was received by Development Services Division, Planning Services, about loud aerial fireworks at your resort at 12:05 am on July 5, 2015. A County Sheriff Deputy was dispatched to the site where he met a security guard at the gate. The subjects responsible for the fireworks could not be found. The Deputy was also told about several loud events with amplified music and karaoke at the resort, possibly in violation of the resort's special use permit. The Deputy suggested that the complaint be forwarded to Planning Services for follow-up.


You and I spoke about this complaint and discussed the following issues on the phone on September 8, 2015. This letter serves as a reminder of your special use permit (S93-0003) and the conditions of approval that regulate the operation of your resort. The conditions are attached for your convenience. Please understand all conditions of your permit and pay close attention to the following conditions that relate to loud noises:

3. Weddings and wedding receptions shall be discouraged. *Please refrain from having these events at your resort unless a Temporary Use Permit is obtained.*
9. The noise level of the campground activities shall be regulated by the following dBA at the property line: 10:00 pm to 7:00 am, 50 dBA and 7:00 am to 10:00 pm, 60 dBA. *An example of a 50 dBA noise might be a refrigerator working or a car driving past, while an example of a 60 dBA noise might be normal conversation in a restaurant or office.*
12. The total Coloma Resort capacity shall not exceed 507 persons at any one time. The number of vehicles shall not exceed 310 at any one time. *On busy weekends/holidays be sure to keep a count of persons/vehicles entering your resort.*

Failure to adhere to these conditions of approval could result in the revocation of your special use permit. This is not the first noise complaint. This letter and complaint will go in your permit file and could be used to build a case for revocation in the future if more noise complaints are received.

The Coloma Resort was granted a conditional use permit by the El Dorado County Board of Supervisors after it was purchased by my parents, Fred & Marielle Faieta in 1988. The Resort has been under the ownership and on-site management of our Family since the permit was granted. For over a quarter of a century we have developed and maintained a continuous high standard of condition, service, security, cleanliness, park improvement, community involvement and educational/recreational opportunities for our community.

I have been the Director of Development & Operations since 2004.

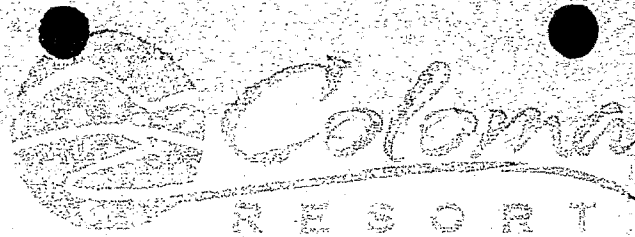
The Resort operates 12 months out of each year and employs 14 full time and 6 part time management team members.

Our Resort oversight is mainly under the jurisdiction of the State of California Housing & Community Development Agency. There are numerous State, County and Federal Agencies that participate in helping to keep health, public safety and compliance within regulation for all campgrounds, trailer parks, and RV parks in the State of California. As of this writing, (January 21, 2014) there are no known violations of permits, nor pending action by any of the regulators assigned to inspect and control the activities of the Coloma Resort.

We have no modular homes on the property. All of our Park Model Units are allowed by HCD regulations. In 2013, the Coloma Resort's Park Model, Bunkhouse and Tent Cabin rental accommodations contributed \$23,390 in El Dorado County "bed tax" alone. Coloma Resort is not only an asset to the community; it is also a monetary asset to El Dorado County.

We have close relationships with all but one seemingly misguided and questionably intended neighbor. We enforce our 10pm quiet hour and keep our neighbors advised when we donate our facility for fundraisers which benefit local organizations such as Coloma/ Lotus and El Dorado County Chambers, Placerville Rotary, local high schools, American Lung Association, Swift Water Rescue Courses, California Search and Rescue Expos, Etc.

We consider our doing business in El Dorado County a privilege not a right. It is my great concern that the unrestrained actions of Melody Lane and her "Compass 2 Truth" platform cause undue cost and harassment to the residents, businesses, The Marshall Gold Discovery State Historic Park, governing bodies and protective agencies of El Dorado County. Regardless, Coloma Resort will continue our position of transparency and compliance.



In conclusion, I would like to restate that there are no mobile homes and no know violations of our conditional use permit. Please call and make an appointment with me for a tour of our treasured facility and to review any and all conditions of approval.

Hi Melody, Jim Goodspeed...I just thought I'd report to you I drove by your gate to see if you're at home but you're not there so I thought I'd leave a message. I called the Sheriff on the Resort last night for the noise and then for the fireworks and I called over at the Faieta's as well and told them I didn't think they wanted felons shooting off fireworks in their Park and that the Sheriff had been called and that they should go down there and take charge. And uh, Marielle called their manager and the manager told them it was all over at the American River Resort across the river. I called Marielle back and told her to get a manager that wasn't full of shit. She had lied and that it was back in their Ropes area. So anyway, we had an interesting night last night and the Sheriff did come out and he inspected, I mean the deputy came out and inspected and searched for fireworks. I don't know what the outcome was, but we had an interesting evening on the 4th. Thanks much. Talk to ya soon. Bye bye.

7/5/14 @ 4:10 PM - I called Jim Goodspeed. Jim said he dialed 911 and they called EDSO. Jim played the long string of fireworks going off for the deputy while on the phone so they could hear what was going on. Jim thought the deputy's name started with a "D". Jim reported that while the deputy was at the resort the person on the loudspeaker got everyone's attention stating, "Let's let everyone know what good neighbors we are!!!" Jim threatened to call the Faieta's every time they made a racket even if it was at 3 AM. He'd go over there himself with a gun to prove his point. I told him to document all incidents with EDSO; dealing directly with the Faieta's was a waste of time. Jim was adamant about being "nice" to the Faieta's and he'd deal with it his way.

At approximately 4:50 PM on 7/5/14 I called Dispatch to get a case file number on Goodspeed's call. Dispatch said there was no case file assigned, just a CFS # 742014-284. Was informed you must request a Citizen's Arrest for a case file number to be assigned. Dispatch operator claimed fireworks was a misdemeanor, not a felony. Most people won't file a Citizen's Arrest because it's just too "messy" to deal with. Informed her that we're trying to do our part as Citizen's Watch but we need EDSO to do their job and enforce the law.

My husband and I have been residents of the Coloma-Lotus area since 2004. We live directly upwind of the river corridor. Every summer and fall we worry about fire. We are particularly appalled, deeply afraid, and frankly very angry to see nightly campfires burning at the campgrounds at the bottom of our road home when we are all so vulnerable to wildfire. We urge you with all our hearts to seek a way to completely ban all campfires, all fires of any kind at all, throughout the summer and fall months in our area. No fires on private property, no fires on public land, no fires of any kind anywhere during the summer and fall months when we are all so terribly vulnerable to wildfires. It is appalling to us that this has not been done sooner.

Several years ago, we were traveling through British Columbia. At that time, they were experiencing the effects of long term drought and a horrific wildfire season was raging throughout the northwestern US and in western Canada. British Colombia had sensibly banned all fires, campfires, home fires, ALL burning of any kind 2 miles inland of the coast (I may be slightly off on the exact miles inland). But, we were struck by how smart and obviously necessary this policy was and wondered why on earth our own community, a thousand miles to the south and far more vulnerable to wildfire, was not doing this too!



Fire Prevention Order

Northern California District

Applegate Field Office

CA-320-20-01

Due to dry conditions, high fire danger, and a shortage of firefighting resources, the Bureau of Land Management (BLM), Applegate Field Office is amending Fire Order CA-320-20-01 to prohibit all uses of open flame on public lands managed by the Applegate Field Office. This order is issued under the authority of the **Federal Land Policy and Management Act of 1976 (43 U.S.C. 1701, et. seq.)** and pursuant to **43 CFR §9212.2**. This open flame prohibition is in effect starting Sept. 8, 2020 until further notice. All other provisions of Fire Order CA-320-20-01 remain in effect until further notice.

Acts prohibited and defined under this order:

- Setting, building, maintaining, attending, or using a campfire, charcoal BBQ, portable stoves, or open flame of any kind is prohibited including within established campground.
- Smoking, except within an enclosed vehicle or camp trailer or while stopped/standing in a designated developed campground with a three-foot diameter area barren or cleared of all flammable materials and away from federal facility doors, windows and air ducts.
- The possession or operating of any welding, acetylene device or other open flame torch that uses oxygen and fuel gases to weld and cut steel or metallic components. Welding and torch definitions and direction pursuant to 43 CFR §912.2, U.S. Department of Labor- Occupational Safety and Health Administration 1910.252(a).
- Possessing, discharging, using or allowing the use of fireworks, pyrotechnic or incendiary devices.
- Shooting, igniting or causing to burn; explosives or explosive material, including binary explosive targets.

Exemptions:

Pursuant to **Title 43, CFR §9212.2**, the following persons are exempt from this order: **Anyone with a special-use permit, specifically authorizing the otherwise prohibited act or any Federal, State, or local Officer, or member of an organized rescue or firefighting force in the performance of an official duty.**

Penalties for violating this order:

Anyone who is found guilty of violating a fire prevention order, which may be classified as a Class A Misdemeanor Offense under 43 USC 1733(a) FLPMA, 18 USC 3559, and 18 USC 3571 Sentence of Fine - Sentencing Reform Act, Oct. 12, 1984, that does not result in death, may be fined not more than \$100,000 and/or imprisonment for not more than 12 months, or in accordance with the applicable provisions of 18 USC 3571. Restitution for total fire suppression and damage costs incurred may be borne by the trespasser.

Hi Lori,

I don't have to tell you California is a tinderbox right now. We've choked in unhealthy air the better part of 3 weeks, and now a fire is 30 miles to the east (with strong east winds blowing). Friends up in and near Georgetown are under mandatory evacuation orders. My anxiety is climbing, and I am sure I am not alone.

My point in writing all this is: Why are campfires being allowed anywhere in our valley (or anywhere in the EDC, or California as a whole) right now? Yes, I know some campgrounds are allowed and are very careful. But, these are not normal times. All it takes is one error, one moment of inattention, one tiny mistake, and our beautiful valley could go up in flames.

A few years ago, we avoided a catastrophe when flames went up at Camp Lotus (a place I dearly love) due to a piece of firewood that was disposed of, but wasn't completely extinguished. It just takes one thing.

I am asking for an emergency moratorium on any campfires in the C-L valley, no exceptions. A county wide ban, would make me even happier. I strongly believe there's got to be some mechanism put in place to temporarily change things like this for the safety of our communities throughout El Dorado county.
